Course Description

Home and Family Living. Three semester hours. Functional study of modern family with special attention to roles, marriage preparation and partner selection. Emphasis on marital adjustment and other essentials of successful home and family life. Examination of current, relative issues of human relations including family planning, sex education, divorce, communications, and marriages under special circumstances.

Student Learning Outcomes

- 1. To introduce students to the diverse definition of "family."
- 2. To help students understand the various theoretical perspectives on families.
- 3. To help students develop an awareness of how gender and women's roles have changed throughout history.
- 4. To develop an awareness of current statistical trends regarding the proportion of singles in the United States.
- 5. To develop an awareness of the value that Americans place on marriage and attitudes related to change.
- 6. Describe family characteristics associated with resilience.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

In this class, you will utilize the Learning Management System (LMS) entitled D2L for portions of instructional and learning methods, submitting assignments, participating in online discussions, and completing quizzes. Instructional Methods

This course consists of lecture and didactic learning methods, small group discussions, and class assignments coupled with experiential learning and application. Discussions

Discussions will be posted throughout the course. These discussions will address various topics. You are required to contribute meaningful input to each discussion.

Family of Origin Activity

Respond to the following prompts as you consider your family of origin:

- 1. Describe your family of origin. Who were your major caretakers? Do you have any siblings? If so, list the birth order of siblings in your family.
- 2. If your parents were living during your childhood, were they separated, divorced, or living together? If they were separated or divorced, how old were you when the separation or divorce occurred and how did it impact your family?
- 3. Describe your earliest childhood memory. What was your age at the time?
- 4. How would you describe yourself as a child?
- 5. In what ways does your family identify with a cultural, ethnic, racial, or religious/spiritual heritage?
- 6. What roles did your family assign to individual members ("the smart one", "the athlete", "the depressed one", "the boss")? How would you define your role?
- 7. How important is education in your family?
- 8. Describe an important family ritual or tradition?
- 9. How did your family handle conflict or problems?
- 10. What did your family do together for vacations or to have fun?
- 11. How did your family celebrate birthdays? Holidays?

This paper must be in APA format 7th edition, which means Times New Roman font, size 12, and 1" margins all around. Please answer all questions fully, 5-8 sentences per question is appropriate. Please make the response to each question a new paragraph. Make sure that you proof your paper. Please upload to D2L. Please note that I will not accept late assignments.
