# **Course Description**

The purpose of this course is to provide students with a brief overview of important historical facets of knowledge about the field of psychology. This includes ancient philosophers and their philosophies, scientific developments, and scientists that have led to the formation of modern psychology. Additionally, a historical perspective of the different fields of psychology will also be covered briefly within this course.

### **Instructional Methods**

This course will be conducted primarily face-to-face with weekly take-home assignments to be completed outside of class. The student is expected to attend all face-to-face meetings in person, which will be held each Thursday afternoon from 4:30 – 7:10 at the Texas A&M University – Commerce McKenny Learning Center.

#### **Assessments**

**Group Psychology Systems Presentation –** At the beginning of the semester, students will be assigned into groups and assigned two "systems" and/or "schools" of psychology. Two times throughout the semester, each group will present one of their "systems" or "schools" of psychology to the rest of the class. Each of the "systems" or "schools" of psychology will correlate to one of the chapters in your assigned textbook. The group, at a minimum, must create a formal presentation including a PowerPoint presentation and develop a 30 – 45 minute, leaning-based activity that demonstrates and reinforces the learning of the content of material presented in the presentation. The students' presentation must contain at least three to four outside resources other than the assigned textbook within the presentation. Simply relying on the assigned textbook for all material presented in the presentation will be considered "average" work and will be graded as such. Acceptable learning-based activities following a presentation may take the form of an academic debate, scholarly class discussion, group activity, or game such as Jeopardy, Family Feud or Charades. The instructor MUST receive both the presentation and lesson plan, (including plans for learning activity), one week prior to the group's presentation. Any student who is absent on the day of their group's presentation, without prior arrangements from the instructor, or a true life/death emergency, will receive an automatic grade of zero on the assignment with no makeup assignment opportunities!

**DSM-V Historical Diagnosis Presentation –** The students' final project for this course will be a written and oral presentation on a mental health condition that is found in the DSM-V. This assignment, unlike the previous two presentations, will be individual, meaning that you will not be able to work on this project with anyone. To successfully complete this project, the student will need to select any mental illness listed in the

DSM-V. After selecting a mental illness, the student will then trace the history of this mental illness, from the time of its discovery to our current knowledge today and explain how the diagnosis and its classification has changed within the DSM-V over time.

Additionally, the student will need to include how treatment, public perception and stereotypes of the mental illness have changed over time. The student will turn in both a formal report and provide a formal presentation to the rest of the class on the final class day. Both the written report and the presentation will be turned in no later than 11:59 on the due date for the student to be allowed to present on the final day of class. Failure to present on the final day of class will result in an automatic zero on this assignment!

**Summative Evaluation –** Two times throughout group presentations, each student will be instructed to complete a summative evaluation of the presenting group. The reason for summative evaluation is three-fold. First, it allows me, (your instructor) to evaluate how well students are learning from one another, second, it encourages active reading/participation, and finally, it allows students to receive feedback on presentation skills from their peers as well as the instructor. As a summative evaluator, you will be provided with a rubric to follow with a set of questions to answer about the presentation and learning activity. As the evaluator, you will need to complete the evaluation typed, (not handwritten), and return it to the instructor by the designated deadline listed on your evaluation. The instructor will email you the summative evaluation form one day prior to the class in which you are expected to be an evaluator. It is advisable that students stay on top of the readings in the class as summative evaluators who are behind on the readings will most likely struggle with the summative evaluations and therefore, will most likely loose points on their summative evaluations. Summative evaluations that only rely on information from the assigned course textbook will be considered "average" work and will be graded as such, therefore outside sources of information are strongly encouraged. No summative evaluations will be accepted past one week after the presentation.

In Class Assignments/Participation – It is expected that students attend all classes, stay current on all readings, and participate in all class activities. Most importantly for this class, students are expected to work closely with their peers. For example, if a group is wanting to reenact a play and are asking everyone to come to class dressed as a famous psychologist...then it is expected that everyone at least attempts to attend class dressed as a famous psychologist and failing to do so will result in a deduction in points on your part, because the presenting group will be unsuccessful in their activity. Likewise, if a student does not attend multiple classes, they are not learning anything from the class. I understand that emergencies do occur, therefore, each student is granted one "get out of jail free" pass. This means that each student can miss one class for ANY reason, and it will not affect his/her grade. For every absence after one "get out or jail free" pass, the student will earn a zero for the in-class assignments/participation portion of their final weighted grade.
