Course Description

The course seeks to provide a historical and relevant framework for abnormal psychology and an in-depth review of psychopathological conditions defined in the DSM-5-TR.

Student Learning Outcomes

By the end of the semester, students should be able to:

- 1. Discuss historical perspectives of abnormal psychology and models of abnormality.
- 2. Discuss psychological disorders and their symptoms.
- 3. Conceptualize psychological diagnoses within the framework of the DSM-5-TR.
- 4. Conceptualize symptom presentations and diagnose differentially.
- 5. Discuss the influence of co-occurring disorders.
- 6. Apply theoretical perspectives to symptom presentation.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students should be able to use internet-based learning management software provided by the university as well as Word processing programs to complete the course successfully.

Instructional Methods

A variety of teaching methods will be utilized to help students achieve the learning outcomes including discussion posts, videos, quizzes, vignettes, short essays, short papers, and a final exam.

Students are responsible to log in to the course each week and complete the assigned readings and activities. Students should also:

- 1. Contact the instructor immediately by email if there is a personal emergency that will prevent logging in to the course.

Assessments

Discussion posts: Students should make weekly assigned discussion posts in response to questions posted by the instructor as well as in response to the perspectives of their peers. Discussion posts should demonstrate respect, critical thinking, and knowledge from assigned readings.

Videos: Videos relevant to the course content will be posted. Students will be required to watch each assigned video and write **a short essay** (one page) describing the content of the video and expressing a thoughtful perspective about the video. The thoughtful perspective should integrate insights from the content covered in the assigned readings.

Quizzes: There will be bi-weekly quizzes covering the assigned course content for each bi-weekly period, except the last biweekly period which will be incorporated into the final exam.

Vignettes: Students will work in pairs or small groups of three to discuss vignettes, conceptualize, and justify diagnoses based on symptoms presented, relevant variables, and the DSM-5-TR framework. They will also include differential diagnoses. The

response to each vignette should be **a short paper** that is at least two type-written, double-spaced pages (Font: Times New Roman; Font Size- 12).

Final Exam: The final exam will cover the course content. A study guide will be provided.
