Topics include electric charges and fields, DC circuits, magnetic fields, fields due to currents

College Physics

Four semester hours including one two-hour laboratory period per week.

This is algebra based physics course. It covers the topics of electric charges, fields, electric potential, capacitance, resistance, circuits and magnets.
