Design and construction of concrete structures including reinforced concrete beams, slabs, columns, walls and footings utilizing the building codes Prerequisites: CONE 332 with a minimum grade of C.

2. Design reinforced concrete beams, slabs, and columns using the latest ACI 318 Codes.
3. Design footings and retaining walls using the latest ACI 318 Codes.
4. Design pre-stressed concrete.
5. How to use software (RISA) in analysis and design.
