### **Course Description**

This course will provide students with key terminology, system concepts, and current cyber threats to organizations and individuals. This course provides a high-level overview of cybersecurity challenges and counter measures, and introduces the Confidentiality, Integrity, and Availability (CIA) framework for designing and analyzing secure systems.
