Course Description

The purpose of this course is to investigate the research process as applied to your chosen topics. Experience is gained in defining a research question. Also, an analysis of pertinent literature on your topic is conducted. Clear and concise writing is emphasized while learning to use the APA writing style. You will also prepare a presentation of your research using Adobe Express.

Student Learning Outcomes. At the end of this course, you will be able to:

1. Define your motivation.

3. Learn to use the online campus library
4. Create a research question that addresses your aspiring career interests.
5. Choose and identify the various components of the APA style, paper elements, and format.
6. Use precise grammar, punctuation, and style.
7. Interact with ChatGPT 3.5 (Artificial Intelligence)
8. Create an annotated bibliography using scholarly sources
9. Create a review of the literature about your career topic using scholarly sources.
10. Prepare a clear and concise research paper by organizing a research topic and using acceptable grammar, punctuation, and APA formatting.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students must become proficient in using D2L Brightspace and should be able to use Microsoft Word. They should also know how to rename files and attach files to an email and the appropriate Dropbox for file submission. Students will be exposed to and learn to use Adobe Express for the final presentation.

Instructional Methods

Instructional methods in this course involve writing assignments that will build toward the final research paper. There are also discussions in which the student will participate. Students must introduce themselves to their classmates and understand and accept the Academic Honesty policy.

Student Responsibilities or Tips for Success in the Course

You are expected to log into the course at least three times per week and check your emails. Announcements and emails are posted on Mondays and may come periodically. Also, even though the homework is due on Saturday nights at midnight, answer your questions early and often.

Assessments

Grading, Key Content Areas, and Assignments: Grades in BGS 402 are based on a student's work in three key content areas: quality, consistency, and quantity. These content areas reflect the course objectives and the core communication skills students must learn. Each content area represents a fixed percentage of the course's content. Since this is a senior-level course, grading will consider content, grammar, spelling, style, and organization. Extra credit will not be assigned.

Final Research Paper

The Final Research Paper is worth 20% of your final grade. Students must use APA style formatting and citations. Additional format instructions are provided along with assignment details in D2L. Assignments are due by 11:59 p.m. (CST) on the due date.

Submitting papers: All written assignments/research papers must be submitted to the appropriate folder within D2L and be produced thus:

- 12-point, Arial, or Times New Roman type, double-spaced, and one-inch margins.
- Always use block left format with jagged right margins.
- Always use tabs to indent the beginning of paragraphs.
- Proofread carefully. Grammar, punctuation, spelling, and style count heavily in this course. You should get the free software Grammarly and check your papers against it.
- All assignments in this class will be automatically submitted to Turn-It-In for plagiarism check. Your research paper and all projects must have a 10% or less similarity index.

Module Assignments

- Module assignments will be given most weeks. These are worth a total of 25% of your grade.
- The module assignment will consist of annotated bibliographies written in short paragraphs and spread over the course.
- As a general guideline, your grade on this portion will be a function of quality, quantity, and consistency.

Literature Review

The literature review is a narrative that you will write from your annotated bibliographies. You might have to review your research more. Still, generally, you will take what you summarized in the annotated bibliographies and make a narration, connecting the ideas and results from the articles you found. It is worth 20% of your grade.

Padlet Discussions (free writing)

The Padlet discussions are worth 25% of your grade. The preferred pattern for the discussion activity is that it becomes a conversation, not necessarily a series of posts and replies. The Padlet platform lends itself to sharing and reacting, including video, images, and writing. This will help us become a community of learners. These free writing activities mean spelling, grammar, and punctuation will not be checked.

Quizzes

Four quizzes, one on the Syllabus, one on References, one on the ChatGPT paper, and one on getting to know you, are 10% of your grade.

Procedure for Assessing Academic Dishonesty

1. If academic dishonesty is suspected, the instructor will contact the student and meet to discuss the specific situation. The instructor should use this meeting to explain how academic dishonesty could be avoided in the future.
2. If it is determined that the student is responsible for an academic dishonesty violation, the student will receive 0 points for the assignment and a written warning.
3. Once academic dishonesty has been determined, the instructor will notify the Assistant Dean of the incident details and meeting date. The student's name and incident details will be recorded in a CID database of Written Warnings.
4. The Assistant Dean will inform the instructor if a Written Warning has been reported in another CID course.
5. If the student does NOT have a previous Written Warning for academic dishonesty reported in CID courses and has additional attempts available for the assignment, the student may resubmit the assignment (this applies to CBE courses only).
6. If the student has a previous Written Warning of academic dishonesty reported in CID courses, the student may NOT resubmit the assignment, and the instructor will follow the procedure detailed in [Policy 13.99.99.R0.03](#) for Undergraduate Academic Dishonesty.
