Media Analyses:

Many political ideas are communicated in everyday life through language and media. Accordingly, you will analyze a piece of media content (e.g. video, text, pictures, memes) based on (3) criteria: (1) what is the main argument expressed in the content? (2) What evidence was used to make the case? And (3) Do you agree with this argument? (Explain why or why not). I will provide a playlist that includes videos the students may watch, or they may select their own if they can make the case that it includes a political argument!

There will be three media analyses total. The due dates are listed in the class schedule and will be submitted online via D2L.

Midterm Exam:

There will be a midterm exam in this course, which will assess the student's understanding of all material leading up to that point.

Test review: I do not believe exams should be overly stressful, so I have devised a system that will ensure you learn the material and do not have to have unneeded test anxiety. The system is as follows:

I will open up a shorter version of the exam that selects questions randomly from a test bank. What you should do is take the shortened exam multiple times to allow the law of averages to feed you all the questions that may show up. For example, if you take the review exam 4 times and you score a 66, 72, 78, and 80, you could reasonably expect to make a B on the exam. You may do the review an unlimited number of times before the exam formally opens, but completion of the review (even once) will earn you 5 extra points on the exam. Please take advantage of this! I will post the review in the week leading up to the exam week.

Policy Proposal:

The student must select a policy issue of their choice and do the following: 1) define the problem that your policy deals with; 2) identify possible solutions; 3) evaluate tradeoffs and obstacles; and 4) reach a solution and make a case for it. Because this is an

outline, though, you do not have to write an entire proposal. Just give me an outline of what you would write if you were a policymaker!

Length requirement: At least 750 words total, but you may write more if you would like.

Once the student has selected their policy problem, they must gather evidence from at least three sources to answer these questions. They are not required to rely on an abundance of sources to seem “professional”, but rather, to use solid evidence to strengthen an already solid argument.

When doing research, ask yourself:

1. Is the information I’m using as evidence scientific, logical, or rational in nature?
2. Have I considered all sides of the argument and made an honest assessment of the facts presented to me?
3. Could the objectivity of my evidence be suspect in any way? (hint: all objectivity can be questioned to some extent, so identifying and adjusting for possible bias is a sign of a good argument).

The student will be asked to cite the sources they used to provide evidence for their argument. I prefer ACADEMIC journals, but reputable news articles are acceptable if the student can verify that the information was true. (No fake news allowed). I do not require more than three sources, but I do encourage more to construct a better argument. For citing statistics, I prefer figures from government agencies (FBI, Census, CDC, etc...). Students may utilize whatever citation format they prefer (APA, MLA, etc.).

Final Exam:

There will be a final exam in this course, which will be cumulative. The students will have one week to complete the exam online via D2L. Exams will open on that Monday at 12am and will close the following Sunday at 11:59pm.

AI use policy

Texas A&M University-Commerce acknowledges that there are legitimate uses of Artificial Intelligence, ChatBots, or other software that has the capacity to generate text, or suggest replacements for text beyond individual words, as determined by the instructor of the course. Given that, this course will allow the use of generative AI, given the following constraints:

1. **Any use of such software must be documented.** Any undocumented use of such software constitutes an instance of academic dishonesty (plagiarism).
2. Generative AI is acceptable only to help gather information, the structuring of a writing assignment, and to answer specific questions students may have before or during the completion of an assignment.
3. Generative AI is in no way acceptable if it is used to generate an opinion or subjective conclusion solicited by the instructor in order to complete an assignment. *e.g. "According to ChatGPT, abortion is morally wrong"; "According to ChatGPT, the second amendment does not permit personal possession of automatic weapons"; etc.*

Individual instructors may disallow entirely the use of such software for individual assignments or for the entire course. Students should be aware of such requirements and follow their instructors' guidelines. If no instructions are provided the student should assume that the use of such software is disallowed.

In any case, students are fully responsible for the content of any assignment they submit, regardless of whether they used an AI, in any way. This specifically includes cases in which the AI plagiarized another text or misrepresented sources.
