Students will work in groups to apply the skills and knowledge acquired to demonstrate their mastery of the discipline through a successfully working prototype project.

Prerequisites: Senior Classification, Cybersecurity Majors only. Course must be scheduled the final semester of graduation and Instructor's consent.

#### **Student Learning Outcomes**

1. Understand workflows for legal and regulatory compliance requirements and procedures as applicable to the course project including IRB, NDA, Consent, etc.
2. Perform project management and planning activities according to the agile methodology.
3. Plan, prepare and conduct effective client communication and project updates.

4. Perform basic and advanced security tasks as relevant to the project scope using appropriate tools, including security testing, risk analysis and assessments, software development, architecture design, threat analysis, etc.
5. Design use-cases and perform relevant data analysis.
