Course Description

This course is a survey of American history from Pre-Columbian contact to Post-Civil War Reconstruction. The course will focus on the major characteristics of the following historical eras: Pre-Columbian American Indian and African societal development; European societal and economic development and colonization; American independence; development of the Constitution; Jeffersonian Democracy; expansion of territory; Jacksonian Democracy; slavery; and Civil War and Reconstruction.
