#### **Course Description**

This course is designed for any doctoral student at <u>any</u> phase in the doctoral program. In this course you will become familiar with life after courses. You will gain information and access to dissertation related forms and processes. Additionally, we will walk through the components of the dissertation, what to expect in the dissertation process, how to effectively work with your dissertation committee, selecting a dissertation topic, developing a realistic dissertation timeline, how to make the most of your dissertation journey, and much more. This is a <u>must</u> class for any doctoral student looking to get a jump start on their understanding of the dissertation process. This course will explore the dissertation phase of the doctoral program and will provide essential resources.

- 1.Demonstrate an understanding of the dissertation process.
- 2. Explain the student's role in the dissertation process.
- 3. Develop autonomy in learning.
