COURSE INFORMATION

Materials – Textbooks, Readings, Supplementary Readings

No materials are required. Students will utilize the university library to locate readings related to their thesis project.

Course Description

This conference course introduces the candidate for the Master of Arts or Master of Science Option I degree to the theories and techniques of educational and psychological research and leads to the completion and acceptance of the thesis. Course is repeated for at least two three-credit hour courses. Graded on a (S) satisfactory or (U) unsatisfactory basis.

Student Learning Outcomes (SLOs)

- **SLO 1**: Students will evaluate research to develop a research project.
- **SLO 2**: Students will synthesize research on their topic.
- **SLO 3**: Students will identify techniques for data collection and analysis.
- SLO 4: Students will write a formal thesis and orally defend their thesis.

COURSE REQUIREMENTS

Assessments

- *I.* **Proposal** Before conducting their project, students will write a formal proposal and orally defend it. This will include a literature review and methodology of the project.
- *II.* **Final Thesis** A final thesis that includes the literature review and methodology along with the results and interpretation of the results will be required. A corresponding presentation will be required to defend the final thesis.

Minimal Technical Skills Needed

Needed Skills needed proficiency in Microsoft Office or similar program is needed. You will also be required to search for articles from the university library. Proficiency in data analytical software (e.g., SPSS) is also required.

Instructional Methods

This is an independent project.

Student Responsibilities or Tips for Success in the Course

Making a structured work plan will help students progress through completing their project at a quicker rate. Set aside time for writing.

GRADING

S/U is the grading scheme. Students are assigned a grade of I while the thesis is in progress, and this grade will be converted to an S upon successfully defending the final thesis. Students may be assigned a grade of U if they are not making progress on their project.
