In addition to examining the state constitution and the institutions that it empowers, a wider look is taken to consider local governments, the political system, and the actors in the political system.” (Quoted from the University Undergraduate Course Catalog)

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students will need to be familiar with the university learning management system, (myLeo Online), Google Classroom, know how to use a personal computer, navigate the Internet, and use basic word processing software such as Google Docs and Google Slides.

Instructional Methods

The following methods of instruction will be utilized for this course:

- Assigned readings from the required textbook.
- Lectures and discussions during assigned meeting times.
- Weekly course work on Google Classroom.

Assessments

Formative Assignments: Assignments and Quizzes

Each week, students will complete an activity/assignment over assigned discussion questions unit content. These assignments will vary in terms of format, however, they could include: brief simulations, responding to prompts, or quizzes over provided videos, news stories, and unit content. The amount of time per activity will vary depending on the type. The dates and times for these assignments on the course outline and in Google Classroom. **Late assignments will not be accepted.**

Summative Assignments: Tests and Writing Projects:

Students will take four exams. All exams will include material from the textbook, lectures, and class discussions. These exams will contain multiple choice and constructed response questions. Students have one class period to complete each exam. The dates for exams will be listed on the course calendar in Google Classroom.

Students will complete three writing assignments in which they will analyze issues, policies and political culture of Texas, evaluate the role of public opinion, interest groups, and political parties, and describe state and local political systems. Students will produce written, oral, and/or visual evidence of knowledge of course material. Assignment descriptions as well as rubrics and citation requirements will be provided in Google Classroom. **Late projects will not be accepted.**
