Course Description

<u>ENGR 1304 – Computer Aided Design (CAD)</u>. This is an introductory course in computer-aided drafting/ design. Students will be taught basic CAD commands, tools, multi-view drawing and dimensioning techniques. This course is a 3 Credit Hours.
