Course Description

This course prepares pre-service teachers to effectively teach social studies in elementary classrooms (grades EC-6). Students will explore age-appropriate pedagogical approaches, instructional strategies, and assessment strategies specific to elementary social studies education.

Student Learning Outcomes

At the completion of the course, students should be able to:

- 1. Implement a variety of instructional strategies appropriate for elementary social studies.
- 2. Integrate children's literature effectively into social studies instruction to increase student engagement.
- 3. Select and utilize primary sources suitable for elementary students.
- 4. Incorporate age-appropriate technology tools and digital resources to enrich social studies instruction in the elementary classroom.
