## **Course Description**

This course explores a diverse selection of multicultural literature aimed at promoting social justice within K-12 educational settings. Participants will critically examine books that address themes such as race, gender, identity, and equity, and analyze how these narratives can foster empathy and understanding among young readers. Through engaging discussions, reflective activities, and practical lesson planning, educators will learn to incorporate these texts effectively into their classrooms, empowering students to engage with social issues and become advocates for change.

## **Student Learning Outcomes** (Should be measurable; observable; use action verbs)

- 1. Students will use critical literacy pedagogy as a framework for planning lessons and various literacy learning experiences.
- 2. Students will demonstrate an understanding of the criteria for selecting texts that reflect cultural diversity and that may address various social issues as they plan literacy lessons.
- 3. Students will demonstrate an understand of how assessments and/or curriculum materials may promote or hinder student literacy achievement as a result of a match or mismatch between student's cultural background and the school's curriculum and/or assessment content.

# COURSE REQUIREMENTS

### **Instructional Methods**

This winter mini course will be conducted entirely online. The professor will provide comprehensive modules that include course content, instructions for assignments, and details for assessments. Students will engage in discussion forums, maintain reflective journals, and create multimedia presentations that will be shared with the class.

## **Student Responsibilities or Tips for Success in the Course**

- Daily Login:
  - Log in to the online course platform each day to stay updated with new information and course announcements.
- Critical Reading:

Engage in critical examination of the literature, focusing on themes of multiculturalism and social justice.

- Reflective Journals:
  - Maintain a reflective journal to document thoughts, analyses, and personal connections to the readings.

#### Assessments

1. Children's or Adolescent Multicultural Book Reflective Journal (3 X 50 = 150 points) (SLO 2)

- a. Students will maintain an online journal to read and reflect on multicultural books chosen for independent reading. In this journal, students are expected to engage with each book critically, evaluating its content, themes, and representation. Additionally, students will assess the suitability of each book for their selected grade level, considering factors such as age appropriateness, relevance, and potential impact on diverse readers.
- 2. Discussion Responses (3 X 50= 150 points) (SLO 1) Students will discuss the appropriateness and authenticity of diverse books.
- 3. Pick your own Final Project (200 points) (SLO 1,2,3) Students will select their own final project (ONE) based on their interests and/or classrooms.
  - a. Research Paper: Conduct research on a specific aspect of multicultural literature and social justice, presenting your findings in a format of your choice (e.g., poster, slide show, infographic). Discuss the implications for K-12 education and how these findings can influence teaching practices.
    - i. Paper must be 5 pages long. Arial or Times New Roman 12, APA formatting, double spacing.
  - b. Curriculum Guide: Culturally Responsive Curriculum Development:
     Create a mini-curriculum guide that integrates multiple multicultural books focused on social justice themes for a specific grade level. Include a list of recommended texts, discussion questions, and suggested activities.
  - c. Multimedia Presentation Project: Students will create a comprehensive multimedia presentation on a specific aspect of multicultural literature and its relation to social justice. The presentation should include the following components: Content Research, Visual Elements, Narration/Explanation
