#### Course Description:

An exploration of the fundamental elements and organizing principles of two-dimensional design and it's integration of color and color theory.

#### Course Objectives/ Student Learning Outcomes

- 1. Be able to recognize and describe the use of the elements and principles of design.
- 2. Develop a basic understanding of color theory and ways to incorporate color into design in a meaningful way.
- 3. Develop strategies for creating effective design using intentional integration of principles of design and color theory.
- 4. Be able to critique artwork through the use of proper vocabulary relating to the elements and principles of design, as well as color theory.
- 5. Create various designs incorporating specific uses of the elements and principles of design, along with color theory to express with personal intentions.

#### **Class Attendance:**

Academic success is closely associated with regular and punctual participation. All students are required to participate in class regularly, and complete assignments as they are given. Any student not participating and making daily and weekly progress will be given a notice, and if delinquency continues, it will result in a loss of points on the participation grade, and possible failing of the class

Evaluation and Grading System: Students are expected to adhere to the following course criteria:

- Daily progress and completing drawings as they are due.
- Work to the highest quality level on each assignment striving toward a professional standard.
- Develop and execute assignments in the designated time allotted.
- Submit assignments on due date and take part in class critiques in a <u>constructive and positive</u> <u>manner.</u>
- Demonstrate a willingness to explore new ideas, techniques, materials, and styles.
- Demonstrate a genuine insight into the creation of art, along with the ability to respond to and discuss the work.

Grading:

- 30% Participation points. Each student will get points for participating in discussions and critiques. One point will be given for each interaction, to a maximum of 20 points. Many of you will far exceed this, but everyone will be required to interact 20 times during the semester to get the full amount of points.
- 30% **Daily Grade**: During the first part of the semester grades will be given on effort and willingness to follow through on the assignments. This will include daily design assignments, any research assignments, and quizes. There will be informal critiques, where students will post their drawing on D2L in group discussions, as well as formal submissions for an official critique by the instructor.
- 40% <u>Major Design Projects</u>: There will be periodic drawings that will be turned in for a formal critique. This is the most important part of the class. Learning to work toward a deadline and with proper presentation is essential in all art classes. These drawing will be given more time to complete and will be presented.
