Course Catalog Description:

A continuation of Drawing 1, this course reinforces basic rendering skills and introduces additional drawing media and techniques. Emphasis is placed on the development of expressive and conceptual capabilities.

<u>Textbook:</u> Books referenced in class are not required, but can be useful. The completion of your sketchbook with notes, drawings, and writing will serve as your individual textbook. *See Grading. <u>Software</u> Requirements: You will need to have access and use University email to correspond with me as needed.

See materials list for what you will need. Some materials will be provided, but not all.

Instructors Additional Description:

Though the course catalog description emphasizes Drawing 2 as "an extension of Drawing 1" there is an opportunity to develop personal expression and style with the way I teach this course. These are difficult to measure, but should be acknowledged as important. Volume of work is only one objective way to measure this type of characteristic. How, or if, the piece is applied outside of the classroom can be another objective measure. Something like a drawing which is presented in public or commercial spaces would be an example. Technical skill comes from good instruction and practice. I will do my job in providing the best possible environment and time for this. I will also try to help you identify and cultivate your own creative expression and individuality. Keep in mind how some projects will feel technical, imagination and creativity need to grow as well.

Student Learning Outcomes:

Individual Projects will have a description and main theme. Grading is based on the Mid-Term and Final Portfolio for these categories as a whole.

A single hardbound sketch book will be an additional grade base on different grading criteria.

Mid-Term Portfolio Grading (Student Learning Outcomes.)

- 1. Development and Mastery of Linear based forms (rod, cone, sphere, cube.)
- 2. Line quality and control. * Or, a range of subtlety and complexity of value/shading.
- 3. Development of activated picture plane. * Control over picture plane, both surface and front to back.
- 4. Cleanliness of work.
- 5. Development of range in drawing approaches.

Final Portfolio Grading (Student Learning Outcomes.)

- 1. Consistency in materials handling.
- 2. Efficiency and use of time spent or invested.
- 3. Personal expression identifiable or useful.
- 4. Cleanliness of work.
- 5. At least one piece matted and framed as a final expression.

Sketch Book Grading (Student Learning Outcomes.)

- 1. Sketch Book has all appropriate notes from class lecture and examples to be used as reference.
- 2. Each page reflects drawings done each day.
- 3. Page is considered a whole space or picture plane, as opposed to singular floating subject.
- 4. Range of information in notes, drawings, and materials usage.
- 5. Work near the end of book is as developed as at the beginning. (Consistency throughout book.)

<u>Grading:</u>

Attendance and Class Participation: 20% Sketch Book: 20% Mid-Term Portfolio: 30% Final Portfolio: 30%

Please note that after three excused or unexcused absences each absence will remove 10% of the Attendance and Class Participation grade. Students missing 5 or more classes will need to drop or request an "X" in order to retake the course at a later date.

Total Grades:

A = 100 - 90% B = 89 - 80% C = 79 - 70% D = 69 - 60%F = 59 - 0% Materials List: Note: Some materials may need to be obtained later in the semester.

-Pencils: Hb, 2b, 4b. Other pencil types are optional, but these three are the primary tool for drawing.

-Kneaded Eraser. Larger is better.

-Metal, hand-held pencil sharpener. Others may work as well.

-Hard White White Eraser. The denser one works best. A pink eraser can sometimes work.

-Medium and Soft vine charcoal sticks. Get the medium size, not the thin or thick.

-Black dry pastel sticks.

-Pigma Pens. (.05 size works best.) Use Black, but other colors are optional for the sketchbook.

-Two water color paint brushes. One round (About 1/4" diameter.) One flat (About 1/2" wide.)

-Large Portfolio (large enough to hold 22"x30" paper. A cheap card stock one is acceptable.

-At least two pieces of high quality drawing paper 22"x30." Arches 88 is preferred but other options will be listed in class later.

-Your own drawing board. This is helpful, but not a requirement.

Please: No mechanical pencils, ball point pens, or non-archival colored markers. I will explain about this in class. There are some exceptions to this rule.

Some materials may be needed later in the semester.

COURSE REQUIREMENTS: Minimal Technical Skills Needed.

Be able to look, read, write, and hold a pencil. Internet research or contact through my university email will be needed in some circumstances.

Instructional Methods

I use a traditional format of lecture, demonstrations, examples, classroom studio practice, and critiques. Weather permitting, some projects will take place outside around campus. Notes for the day or upcoming opportunities may be posted on the dry erase board.

Student Responsibilities or Tips for Success in the Course

Be at class on time with the proper materials. Put the time in needed to improve on weak areas and to also make what you are already good at look more professional. Follow university guidelines as far as how to treat each other.
