Students will be required to take one weekend field trip with the class. The date will be announced prior to the beginning of the semester.

Catalog description: Philosophy of outdoor education in a physical education program; designing and implementing outdoor adventure activities in an experiential and interdisciplinary manner for reinforcing the Texas Essential Knowledge and Skills.

Prerequisites: Instructor approval and 2.5 overall GPA.

Course objectives

Upon completion of the course, the student should be able to...

- 1. develop an interdisciplinary lesson using outdoor adventure activities, intentionally reinforcing the TEKS (Texas Essential Knowledge and Skills).
- 2. teach an interdisciplinary lesson to peers, working with a partner and teaching an interdisciplinary outdoor adventure lesson that intentionally supports TEKS.
- 3. examine outdoor clothing and be familiar with appropriate ways to dress for outdoor adventure activities.
- 4. apply backcountry Leave No Trace Principles.
- 5. write a definition for Outdoor Experiential Education.
- 6. discuss the theoretical basis of Outdoor Experiential Education and issues and trends in Outdoor Education.

Additionally, students will participate in at least 8 of the following adventure activities: paddling (canoe, kayak, stand-up paddleboard), archery, outdoor cooking, fishing, primitive skills, initiative games, compass/GPS skills, rock climbing, ropes course activities, trail biking, hiking/trekking, and others as possible.

Homework

Within the online part of the class, you will find instructions for 2 assignments. This part of the course will count for 5% of your entire grade (50 points).

Quizzes

Before some classroom days, there will be a quiz in the online portion of the class that you must submit no later than 11:59pm on the specified date. Each quiz will require that you read any assigned materials and/or view any assigned videos, etc. Quizzes may also cover information that was presented in class.

Written exams

Each test will have several types of questions: define and explain, short answer, essay, fill-in-the-blank, true/false, etc. Study the material indicated by the objectives listed on the schedule. Also study material that was supplied by notes and supplemental materials. Be able to APPLY the information learned, not just recite definitions and lists. For each test, you will have an allotted amount of time. At the end of that time, your test must be submitted.

Partner lead

With an assigned partner, you will lead an outdoor activity, challenge, or initiative. Detailed instructions and evaluation rubrics will be provided.

Solo leads 1 & 2

By yourself, you will lead two outdoor activities challenges, or initiatives. Detailed instructions and evaluation rubrics will be provided.

Final Project

For your final project, you will create and implement an outdoor education lesson, applying the concepts addressed during the course and using appropriate TEKS. The lesson must 1) focus on teaching of outdoor adventure activity (TEKS), 2) integrate at least one other curriculum area TEKS into the lesson for purposes of reinforcement and making connections, 3) highlight one or two character qualities that are relevant for the activity itself, and 4) include a plan for assessment of student learning. Detailed instructions and evaluation rubrics will be provided.

Student and Instructor Expectations

Expectations are high for both of us. I strive to be the best teacher possible. I expect you to perform to the best of your ability. Making an "A" in this class is quite an accomplishment, and will be earned only by those who are willing to put forth the necessary effort. There is no grading curve - you will be assigned the grade you earn!!!!

Class Policies

- 1. Students are expected to be in class <u>on time</u>, ready to participate.
