## **Course Description**

A course designed to provide knowledge related to individuals with disabilities and the effects of these disabilities upon motor development and the performance of motor activities. Categories of disabilities include orthopedic difficulties, learning challenges, cardio-respiratory disorders, behavior disorders, sensory impairments, and other permanent and temporary disabilities. Prerequisites: 2.5 GPA and junior/senior status.

### **Student Learning Outcomes**

1. Demonstrate an understanding of the federal law mandating services for students with disabilities (SWD).

- 2. Demonstrate an understanding of the characteristics of SWD
- 3. Demonstrate knowledge of a variety of teaching strategies for SWD in a physical education/sport setting.
- 4. Demonstrate knowledge of the benefits of physical education for SWD;
- 5. Demonstrate the ability to assess and evaluate physical fitness and motor skills through the TGMD-3, Brockport Fitness test, and CTAPE;
- 6. Demonstrate the ability to establish goals and formulate behavioral objectives for individual students based on assessment results.
- 7. Demonstrate the ability to modify the physical learning environment for individual and group participation in actual practical settings.
- 8. Demonstrate an awareness of the indicated and contraindicated activities for people with a variety of disabilities.
- Demonstrate the ability to develop an appropriate individualized education program (IEP); and
- 10. Demonstrate the ability to use technology for video modeling, as a reinforcement tool, and as a motivational device.

## **COURSE REQUIREMENTS**

You will be expected to use D2L, Microsoft Word and Microsoft Excel.

Independent learning, quided discovery, peer teaching, direct instruction.

### Student Responsibilities or Tips for Success in the Course

### How to succeed in this class:

- 2. Study the assigned material before every class! It is expected that you purchase and read the text (**bring to class**).

- 5. 10% will be taken off for assignments turned in without class attendance.
- 6. Do quality work!
- 7. Proofread your work aloud. Points will be taken off for submitted work that includes: spelling, punctuation and sentence structure errors. No TEXT language.

- Take responsibility for your own grade; I do not give you a grade—you earn a grade.
- 9. If you are late or absent, it is your responsibility to obtain any missed information. Connect with a classmate prior to asking the instructor about missed content.
- 10. On activity/lab days, students need to be dressed appropriately for activity (comfortable/athletic clothes, APPROPRIATE/MODEST clothing, and proper gym shoes, NO FLIP FLOPS, SANDALS or CROCS). Full lengths shirts are required.
- 11. Be ready to move! Participation is required. Activity accommodations can be made.
- 12. Absences, late assignments, missed exams or other will be considered in the event of documented medical or immediate family emergencies. Events must be communicated within 3 days and documentation will be requested (date, time, location required). Communication is key.
- 13. Grades, updated class outline and more in-depth assignment descriptions will be posted in D2L. CHECK IT
- 14. Volunteer opportunities and extra credit may be offered throughout the semester. Take advantage, do not ask for extra credit the last week of classes.
- 15. Be respectful to all. PG 13 classroom language, prepare for your future in a professional setting. A warning will be given, but if the behavior continues YOU will be asked to leave.
- 16. Students who are unprepared for class may be asked to leave.

# Assignments & Quizzes (50%)

Assignments and quizzes will be based on assigned readings and course discussions. Students may be asked to share content during class.

Quizzes measure comprehension of class topics and aid students in preparing for exams. Quizzes will be random and given without notice to students at the beginning, middle or end of class. Quizzes may be short answer, multiple choice, true/false, listing, etc. Quizzes will be paper pencil and/or on D2L (with a code), bring a device. You must be present at the time of the quiz to take it. Make-ups will not be allowed, unless it is a university excused absence or medical emergency.

Assignments will be posted in D2L and in person.

# **Observations/Reflections (15%):**

Students will be required to complete a total of five hours (5) of observations outside of class. The goal is to observe a setting that promotes physical activity for individuals with disabilities (i.e., Special Olympics, disability sport or other). Observation site options are listed in D2L. Connect with the instructor about plans. Follow-up reflections and documentation will be required. 2 of the 5 hours can be during an on-campus event (i.e., HHP hosted event).

**Exams (35%):** Mid-term and Comprehensive final exam will give students the opportunity to apply content learned from course (material from text, class discussions, teaching experiences and observations).
