##### Course Description

- This course examines the unique nature of the adult learner in higher education in contrast with young learners in K-12 classrooms. Emphasis will be placed upon theories of andragogy and practices in adult learning.

### Student Learning Outcomes

Upon completion of this course, students will be able to understand and apply

- adult learning theories to their own experiences and skills;
- andragogy and pedagogy related to adult learning and development;
- the meaning of adult education to any teaching and learning situations;
- critical pedagogy, critical literacy, and dialogical pedagogy in adult and higher education.

### Grading

Forum Discussions and Feedback (80% of grade)

- Students are required to write postings and to respond to at least 2 of their peer's postings on each learning modules. No late work will be accepted.
- In their postings, students are required to synthesize, apply, evaluate, or connect to the contents in the required and supplemental readings. Relying solely on the lectures and the textbook will be considered average work and will be graded accordingly. In addition, please remember to cite all references appropriately, quoting any use of exact wording of authors and adhering to APA and university standards. Deviation from these standards will also result in a reduced grade.
- Generally, a thoughtful discussion posting on each assigned learning module is due by Thursday of the second week and feedback on their peers' postings is due on Saturday of the third week. Both parts must be completed in order to receive full credit. Failure to complete one or both components will result in no points/credit awarded for that module.

Final Term Paper (20% of grade)

- Submission of a term paper reflecting a comprehensive application of concepts gained from the class contents.

The final grade will be based on the following ranges:

- A=90 to 100%
- B=80 to 89%
- C=70 to 79%
- D=60 to 69%
- F=59% or lower

### **Course Engagement**

### **Late Assignments**

Unless stated differently elsewhere in the syllabus, there will be a 10% penalty for written assignments turned in late. In some instances, failure to turn in an assignment has a rippling effect on other components of the class, such as timely threaded discussions or collaborative exercises. In such cases, you will be assigned an "F" for the class.

### **Respect Differing Views**

As with all graduate courses, this course deals with ideas and opinions. It is important to be courteous and respectful of individuals who have expressed opinions and beliefs that are different from your own. In a disagreement, please ask for an explanation and rationale for their beliefs or opinions. Often, matters are more complicated than they seem. Only civil, sincere, and even tempered written discussions will be permitted in this course.
