Course Description

An individual study of dramatic theory, development of the script, and analysis of original scenes and plays. The course also includes the research and development of a completed dramatic work. (Prerequisite: Consent of the instructor)

Student Learning Outcomes (Should be measurable; observable; use action verbs)

- 1. The student will be able to understand both the basic and the more advanced tenets of playwriting within the parameters of a dramatic work.
- 2. The student will be able to identify a variety of playwrights and styles.
- 3. The student will be able to complete a fully realized dramatic work.

Instructional / Methods / Activities Assessments:

Students will be graded on a series of reading selection, class projects, practical application of the knowledge that they have learned, the completion of a realized dramatic work, and exams.

Minimal Technical Skills Needed

Students must have access to a computer and the ability to use Microsoft Word or other word processing software. Students must also be familiar with how to use the D2L Brightspace platform including uploading documents to Dropbox as .pdfs.

Instructional Methods

Students will be graded on a series of reading selections, class projects, practical application of the knowledge that they have learned, the completion of a draft of work about or using the principals learned as well as posted class discussion and exams.

Student Responsibilities or Tips for Success in the Course

- 1. Be prepared. Read what needs to be read. Write what needs to be written.
- 2. Participate. There is a great deal of exciting discussion in this course, and it will be even more exciting with your ideas.
- 3. Check your school e-mail regularly.
- 4. Be respectful of your instructor, your classmates, and yourself.

Grading

Details for all assignments will be provided by instructor.

Reading Reflections (20%)

Students will summarize and respond to weekly readings about the craft of playwriting.

Writing Activities (15%)

Students will complete short writing activities using theories/styles introduced in weekly readings.

The syllabus/schedule are subject to change.

Discussion Posts (10%)

There will be a minimum of 3 discussion post assignments. Students will be required to create their own post and response to a minimum of two posts by other students for each assignment.

Rough Draft (20%)

Students will complete a rough draft of a short play (or section of a larger work) using a theory of combination of styles learned and practiced in weekly assignments.

Rough Draft Reader Responses (2 @ 5% each – 10%)

Students will read two rough drafts written by fellow students and complete a response form.

Second Draft (25%)

Students will complete a revision of their first draft using feedback from fellow students and the instructor.

Student Grievance Procedure

Students who have concerns regarding their courses should first address those concerns with the assigned instructor in order to reach a resolution. Students who are unsatisfied with the outcome of that conversation or have not been able to meet individually with their instructor, whether in-person, by email, by telephone, or by another communication medium, should then schedule an appointment with the Department Head or Assistant Department Head by completing a Student Grievance Form (available in the main office, HL 141). In the event that the instructor is the Department Head, the student should schedule a meeting with the Dean of the College of Arts, Sciences, and Humanities after following the steps outlined above; if the instructor is the Assistant Department Head, students should schedule a meeting with the Department Head.
