Course Description:

This advanced course focuses on human physiology. It provides a comprehensive understanding of how each organ/tissue works down to the cellular level and what role(s) each organ system plays in maintaining homeostasis. This information is then used to solve case studies involving human physiology. Emphasis will be placed on human physiology and the integrated functions of organ systems. Students are expected to learn the basic principles and concepts of human physiology both at the molecular and cellular levels, to learn to reason scientifically, and to understand and describe the cooperative functions of multiple organ systems in the human body. The emphasis is on understanding mechanisms rather than on memorizing details, but sufficient detail must be included to serve as a basis for later understanding of abnormal function and its consequences in disease states and for understanding rational therapy with drugs and other interventions.

Student Learning Outcomes: Students completing this course will be able to:

1. Explain physiological mechanisms by applying basic principles of physics and chemistry.
 2. Describe the fundamental mechanisms underlying normal function of cells, tissues, organs, and organ systems of the human body.
 3. Explain the basic mechanisms of homeostasis by integrating the functions of cells, tissues, organs, and organ systems.
 4. Apply knowledge of functional mechanisms and their regulation to explain the pathophysiology underlying common diseases.
 5. Effectively solve basic problems in physiology and pathophysiology, working independently and in groups if possible.
 6. Identify and utilize appropriate reference resources to clarify and expand knowledge of physiology and pathophysiology.
 7. Critically analyze information on a selected topic in physiology and think **experimentally and critically** about the concepts described above
 8. Cite literature properly and use your own words where any text needs to be written.
- More specific SLOs will be outlined and discussed with each topic covered.

Course Requirements:

- Proficiency in using the D2L Brightspace Learning Management System through myLeo Online
- Proficiency in use of Microsoft Word, and PowerPoint
- Other relevant graphics programs for preparing effective PowerPoint presentations

Instructional Methods: Instruction will consist of web-based delivery of notes, some short videos and student-oriented appointments. Learning will also be achieved through reading of relevant chapters in the recommended textbook. PDF files of all notes will be made available in the D2L Learning, Management System at myLeo Online. Announcements and reminders for important events will also be regularly posted through this system. Course progress can be monitored through the online system.

- Dedicated study time each week to go over the materials at D2L and the information in the relevant book chapter(s)
- Regularly check both myLEO Online and university email accounts for announcements or class emails.
- Attend and participate in discussions via forums at D2L.
- Submit exams and assignments on time.

Course Specific Procedures/Policies

Assignments: At home questions and/or research will be assigned two times during the semester. Be sure to check D2L announcements for updates.

Quizzes and Exams: Consist of multiple-choice questions (70-80%) and essay-type answer questions (20-30%). The quizzes will be from each chapter of two trials (highest grade will count). The term exams will be taken at the date range in the course schedule and the final exam will be partly cumulative (as set in the Course Schedule) and take place during the university final exam week. Some questions for exams from a given chapter may be derived from the same Test Pool and repeated.

Makeup Policy: The student is responsible for requesting a makeup when they are unable to attend the regularly scheduled examination and must schedule the makeup within 2 days of the absence. Makeup exams will be scheduled only in the event of an EXCUSED absence (as defined in the Student's Guidebook). If the test is not made-up, the student will receive a zero for that exam.
