Course Description

ENG 1302 – GLB/US Written Argument/Research • 3 credit hours. This course provides students with advanced training in communication skills emphasizing the writing and reading of argumentative prose and adapting writing to alternate audiences. Students will write weekly, including such texts as journals, reading response logs, summaries of argumentative texts, argumentative papers, and longer papers integrating secondary research. Activities include close reading of sample texts, both student and professional. Some sections will emphasize special topics in both reading and writing. Prerequisites: Grade of C or better in English 1301 or advanced placement or CLEP.

Core Curriculum Course Objectives

- **Critical Thinking Skills:** to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information;
- **Communication Skills:** to include effective development, interpretation and expression of ideas through written, oral and visual communication;
- **Teamwork:** to include the ability to consider different points of view and to work effectively with others to support a shared purpose or goal;
- **Personal Responsibility:** to include the ability to connect choices, actions and consequences to ethical decision-making.

English 1302 Learning Outcomes

- **Define** important terms/concepts including, but not limited to, literacy, community, research, ethics, knowledge, ethnography, and writing processes;
- **Discuss** the ways these terms expand based on cultural and communicative practices;
- **Locate** scholarly research related to key terms/concepts;
- **Examine** scholarly, personal, and/or multimodal texts that detail varying understandings and applications of key terms/concepts;
- **Develop** writing and research processes appropriate for ethically studying the literacy of a specific community;
- **Engage** in collaboration that supports individualized and communal understanding and writing development;
- **Collect** primary ethnographic data;
- **Organize** collected data in order to understand specific literacy community practices;
- **Consider** the various affordances and constraints of composing using different technologies (analog, digital, and/or multimodal), research methods, practices, styles, and/or languages;
- **Compose** texts across different genres and media of writing that further expand key terms/concepts based on primary ethnographic research and engagement with trustworthy secondary research;

- **Reflect** on your writing experiences and literacy practices;
- **Design** individualized learning goals appropriate for a first-year writing course; and
- **Assess** individualized learning goals based on labor and performance alongside feedback from peers and the instructor.

Student Responsibilities or Tips for Success in the Course

The following list offers guidance that may be helpful to in your academic studies this semester:

1. **Print vs digital learning:** Although our textbook is digital and always available online through the *TopHat* platform, you should know that the school library offers free printing to students, so it is possible for those who learn better through analog means to print their readings, assignment sheets, and other course materials. I highly encourage you to take advantage of the library's many free services this semester.
2. **Annotations:** Writing notes in the margins (the blank space on the sides) of a text can greatly help you engage with the reading material. Frequent annotating practices can help you track your comprehension of the material or serve as reminders for questions you can raise in class; these notes may even come in handy when you have to write about issues in class.
3. **Scheduling:** Creating a schedule (and sticking to it!) can help you cut down on procrastination, meet deadlines, and reduce stress. Make sure to create a realistic rather than an impressive schedule!
4. **Peer-Review:** Social relationships in college are essential to improving your work performance. Class buddies can offer academic, social, and emotional support, so be sure to be more open to creating friendships in class this semester.

COURSE ASSESSMENT

As an instructor, my approach to classroom assessment is centered on the idea that written work must undergo a rigorous editing process before it can be evaluated; thus, major essays in this class will be graded only once each student has had several opportunities to shape (and re-shape) the work according to their artistic and academic designs.

Students will submit rough drafts of their work first and receive full credit for a writing activity grade (if the work is complete and submitted on time). Once I return the draft with my feedback, students can revise and edit their work and submit the revised version for a final grade for that writing assignment. I will assess the work by consulting a rubric designed to evaluate an essay's purpose, development/support, organization, and clarity. Since no rubric is perfect, I will round up or extrapolate a grade from the total grade it generates.

Most other daily/written assignments will receive full credit or be graded with single-point rubrics.

Midterm and final grades in this course will be based on the following scale:
