**Course Syllabus:** Spring, 2025

## Course Information

### Course Description

Provides piano majors or students with intermediate to advanced piano skills training in jazz piano skills, including comping, basic improvisation, reading lead sheets, jazz theory, and jazz piano history.

### Student Learning Outcomes

In this course, students will:

1. Demonstrate understand of most important events and figures in jazz history.
2. Demonstrate understanding of the jazz pianist as a solo player and in jazz ensembles.
3. Learn and perform accurately at least two ensemble pieces, with the student pianist playing lead.
4. Learn the stylistic rudiments of the ballad and blues styles, with improvisation.
5. Demonstrate understanding of lead sheet realization.

### Required Textbook

All students must purchase “The Real Book” sixth edition, published by Hal Leonard. This book can be obtained through local music stores, online music stores, or Amazon.

All students must purchase the APP “iRealPro” which is available for both Apple and Android platforms.

# Course Requirements

## Instructional Methods

Instruction will be given in the form of online lessons (½ hour weekly). A Zoom link will be provided for the lessons.

## Assessments:

By the second week of the semester, all students must have purchased copies of their music and the iReal Pro app.

**Required Practice:** Students are required to practice daily. Suggested practice routine is 30-60 minutes per day at least five days per week.

**Midterm Project:** All students will be required to write a brief paper for their midterm project. The paper should include a brief history of jazz, and should focus on at least two important pianists in jazz history, along with the importance of their role in shaping and/or changing jazz style. The paper should be between two and five double-spaced typed pages in length. The due date for this project is no later than March 15, 2024. Papers received after this date will have 10 points deducted from the overall grade for each day the paper is late.
