The student teams are expected to gather relevant information, constraints, and data from the industry client and to translate this information into system requirements and specifications. The student team members rely on skills and knowledge attained during their undergraduate program to complete the design/execution phase. The project is team-based so a component of leadership and team dynamics is also integrated into the curriculum.
