Course overview:

This course is designed for students who have taken introductory genetics and have a general familiarity with cell and molecular biology. Therefore, this course provides students with an indepth investigation into DNA technology and practical application of genetic study. Emphasis will be placed on eukaryotic gene mapping, gene functional studies and on genomics, and its practical applications. Students are expected to gain an in-depth understanding of analysis, strategy and experimental logic used in deriving the basic principles and concepts of genetics at the molecular level.

Student Learning Outcomes (SLO):

At the completion of this course students will be able to:

- 1. Describe the development of gene concept.
- 2. Describe the molecular structure of genetic material and its replication.
- 3. Describe the molecular basis of mutations and DNA repair.
- 4. Describe molecular mechanisms of recombination and transposition
- 5. Understand methods of gene mapping and cloning of genes.

Required Textbook:

GENETICS: ANALYSIS+PRINCIPLES 8th edition, ISBN: 1266823816

We will cover part of the subject matter presented in this book, but not necessarily in order. Chapter assignments are listed on the Course Schedule. Subject material of this course is built on facts and concepts covered in undergraduate courses at A&M-Commerce BSC 303 Cell Biology and BSc 304 Genetics. Those who haven't finished these courses may find this course difficult. Therefore, I highly recommend you to review materials from your undergraduate genetics/cell biology/molecular biology courses.

INSTRUCTION METHOD

This syllabus is a suggested outline. It represents the minimum material that we will cover in this course. Dates are approximate and subject to change. If there is any major changes to the syllabus it will be posted in e-College and the syllabus will be updated accordingly. You are responsible for keeping up with any changes made to the syllabus. You may be tested on any material listed in the syllabus, on your class page and discussed in class.

Web-Based Course: The structure of this course is predicated at student reading. Considering enormous volume of information available in genetic engineering, it is impossible to cover everything in a course. Since it is a summer course it will be rather intense and 2 chapters of reading will be required per week. This means you need to spend a considerable amount of time in studying and integrating the materials. I have selected these chapters to provide basics in Molecular Genetics. PowerPoint slides, additional reading materials as well as activities will be included to help your learning. Your progress in this course will be measured using weekly quizzes, two exams (a mid-term and a final), and a debate topic. You can monitor your progress in D2L Gradebook.

How to Succeed in the Class: For successful course completion, your active and timely participation is essential. As an online class on Molecular Genetics, I expect that you have a back ground in molecular/cell biology and genetics. You must read chapters prescribed for each week and go through additional lecture materials, assignments and activities. From my prior experience, exchanging e-mails are poor strategies of online learning, therefore, *I encourage to clear any questions that you may have during electronic office hours (MWF 2–3 PM) via Zoom feature available in D2L-Brightspace.*

Class Policies:

In an online class students are required to be self learners and self-directed. The fact that you might be taking several online classes and working full time may put additional pressure on you, but would not be considered as a reason for diluting the rigor of this course. This class will keep the rigor, time line, and standards of a face-to-face class.

E-mail and Communication: If you are e-mailing me please use your university e-mail account and put BSC 513, Molecular Genetics in subject line. If you use an e-mail account without an ".edu" extension, it may end up in my spam folder. During work days, I will respond to e-mails that I receive within 24 hrs. Since I check e-mails occasionally on weekends, e-mails received on weekends will be responded on the next working day. Most of the correspondence will be announced on the course homepage, therefore check course homepage in D2L-Brightspace asoften-as possible.

Electronic Office Hours: You may access office hours on Monday, Wednesday, and Friday at 1–2 PM CST.

Lecture Materials: Power Point slides that I use for delivering lectures are available in D2L. However, I would like to stress that *Power Point slides that I use for my lectures must not be treated as lecture notes. You may use it as a reference or guide to read the book but not as study material.* If you ONLY use the PowerPoint slides for study, you may not perform good in tests. *Materials provided in this course including lecture slides are copy righted and must not share them without obtaining permission.*

Overview of Assignments:

- 1. Weekly Quizzes (20% of Total): After covering each unit, there will be a quiz which needs to be taken online in D2L. Quizzes are due @11.59 PM on specified dates in the course calendar. If you miss a quiz or perform poorly, there won't be any makeup quiz.
- 2. Problem Solving Assignments (20% of total): At the end of each unit/chapter, a set of problem solving questions will be assigned, which are due in a week. It works for your advantage to solve these problems by yourself as you go along the week, which will increase your success in weekly quizzes and later in exams. Solving problem sets will also augment concepts covered in lectures and help you retain them.

Completed problem sets mus be submitted in D2L; note that emailed copies of problem sets would not be evaluated and credited "zero" points. For full credit assignment must included detailed steps of problem solving.

Exams and Grades: There will be two exams including the final. Exam questions will test critical thinking, analytical ability, and the understanding of subject matter. Therefore, it is important to understand the concepts. *If you miss an exam for reasons other than university-approved emergencies, make up exams would not be provided. In the event of a make up examination, it will be provided only in the A&M-Commerce campus, that means you need to travel to the campus.*
