Course Description

(ENGL 2331) Literature of the Western World. Three semester hours. A study of selected works of fiction, poetry, and drama in the literature of western civilization from classical times to the present. This course will focus specifically on British literature. Prerequisite: ENG 1302.

 Personal Responsibility: to include the ability to connect choices, actions and consequences to ethical decision-making.

English 2331 Learning Outcomes

Upon successful completion of this course, students will:

- Identify key ideas, representative authors and works, significant historical or cultural events, and characteristic perspectives or attitudes expressed in the literature of different periods or regions.
- Analyze literary works as expressions of individual or communal values within the social, political, cultural, or religious contexts of different literary periods.
- Demonstrate knowledge of the development of characteristic forms or styles of expression during different historical periods or in different regions.
- Articulate the aesthetic principles that guide the scope and variety of works in the arts and humanities.
- Write research-based critical papers about the assigned readings in clear and grammatically correct prose, using various critical approaches to literature.

Instructional Methods

This is a face-to-face course, meeting on-campus at Dubiski in A416.

- Check grades frequently and communicate with your instructor regarding any questions or concerns

COURSE ASSESSMENT
