#### **Course Description**

Introduces students to the workings and interrelationships of the U.S. and world economies. Covers economic analysis principles, including aggregate economic activity, national income determination, monetary and fiscal policy, and business fluctuations. Focuses on real-world problems like poverty, inflation, unemployment, and economic instability.

#### **Student Learning Outcomes**

1. Explain how choices and trade improve welfare.

- 2. Be able to use the supply and demand model to analyze the decisions of individual consumers and producers, understand the dynamics within specific markets, and evaluate the overall market equilibrium.
- 3. Utilize microeconomic data to calculate and analyze specific economic variables such as price elasticity, production costs, and market structures. Discuss the strengths and limitations of these economic measures in explaining the behaviors of individual decision-makers and market outcomes.
- 4. Model the impact on consumers and firms of changes in microeconomic variables such as prices, production costs, and market structures, and assess how these changes influence market efficiency and economic welfare.

# **Course Requirements**

- **Participation:** Regular attendance expected, both face-to-face and via Zoom as needed.
- Assignments: Weekly assignments through D2L, due Sundays by 11:59 PM.
- **Exams:** Three exams, including a comprehensive final, conducted online.
- Instructional / Design of Course Overview

This course is a face-to-face course offering. It is expected that students attend regularly. However, all lectures are streamed via zoom and recorded. Students need to prioritize face-to-face attendance; however, students are permitted to attend via zoom for reasons such as safety, illness or isolating from exposure to a sick individual. Face-to-face students are required to attend in person in order to receive credit for attendance.

 This course relies heavily on the D2L learning system. The course is separate into weeks. Each week opens on Monday and students should use the checklists found

- in D2L to identify what is due each week in terms of content and/or assignments. Each week opens on Mondays and closes on Sundays at 11:59pm.
- There will be a combination of recorded and live instructional content throughout the semester. There will be 3 live lectures each week (see time and location above). The attendance policy of the course is located under "Lecture Attendance" in this document. Students need to prioritize attending the live lecture in person and use Zoom online stream when needed.
- The course is structured so that students can learn in various formats. The professor will use various learning tools to help students master the course learning objectives. Students are expected to read the assigned chapters in the textbook, watch additional videos, and at times review other instructional resources. Students should commit between 6-9 hours of study time per week at a minimum (not including lectures).
- Students will be assigned weekly homeworks in D2L to help master the learning objectives. All homework and lectures are required to be completed by Sunday at 11:59 PM. Finally, there will be 3 exams in the course with the 3rd exam being a comprehensive final exam. See the course schedule for more details on due dates. The professor may or may not offer extra credit assignments. All exams will be completed online throughout the semester.
- The professor will not repeat questions that can be found within the syllabus. Furthermore, the professor will not answer questions regarding the class or content that have been addressed in lectures and/or e-mails to the course.

#### **COURSEWORK/GRADING**

- 20% **Exams** (60% of final grades each) There will be three exams in this course and each exam counts 20%. ALL exams will be administered online for this course. The 3rd exam WILL be proctored. Exams open on Fridays at 12PM and close at 11:59pm on Sunday night on the week assigned. The professor may provide an extension or open exams earlier. There are three exams including the final. The 3rd exam (final exam) is comprehensive and will cover all course material covered during the semester. Students are responsible for information from live/recorded lectures, required readings, and any guest speakers. There are no makeup exams. The professor will allow the final exam score to replace ONE of a student's previous exam score if the final exam score is higher.
- Weekly Homework Assignments (20% of final grade) Students will be assigned weekly homework assignments. The Homework assignments are in Pearson MyEconLab which can be found in the course in D2L. Students are allowed two attempts for each homework assignment and the highest grade will be used for grading purposes. The homework is intended to help students apply their knowledge and help prepare students for exams. The professor will drop the lowest homework assignment grade for each student when calculating final grades. The professor has the authority to remove any student from a group or give a zero if necessary.
- Lecture Attendance (20% of final grade)
  The lecture attendance is simple students should attend all lectures in the classroom.

Some attendance grades will be a quick pop quiz, and some will be simply signing the attendance log. It is important to understand that attendance also encompasses participation in the course. Students in the face-to-face section of this course will be randomly selected for attendance. Attendance counts for 20% of a student's overall grade.

 The professor will drop 2 missed attendance grades for each student when calculating final grades.
