### **COURSE DESCRIPTION / INSTRUCTOR PHILOSOPHY**

An academic course, particular a college-level course, that is focused on Public Speaking should be primarily focused on precisely what its name entails: PUBLIC SPEAKING. This means all students will be required to actively engage in class discussions and make oral presentations to the class. These presentations will be of varying length and will suit specific purposes—informational, persuasive, informal, community awareness, research findings, etc.

This is an interdisciplinary course in speech and public address. I encourage students to research and present topics that are of high interest to themselves. When we explore topics of interest, we are more inclined to demonstrate the confidence, passion, and preparedness that are all hallmarks of effective communication. Students will find that these skills will help them in other academic courses, as well!

Grades for this course will be based on a variety of targeted outcomes. These include written arguments, presentation outlines, peer review and feedback, and (most importantly) the students' presentations, themselves.

### **COURSE REQUIREMENTS**

All students must have access to and use either Microsoft Word or Google Docs for all written assignments. Students must also have access to and use PowerPoint, Google Slides, or Canva for their slides to support their presentations. Any exceptions to these requirements must be requested through the Course Instructor.

## **STUDENT COMPETENCIES / LEARNING OUTCOMES**

By its design, Speech 1315 is a very dynamic, participative course. Academic success, which includes discernible growth in both speaking and writing, will be evident when students:

- a. will be able to identify key communication terms and concepts.
- b. will be able to research, organize, write and deliver speeches of varying lengths.
- c. will be able to demonstrate effective uses of non-verbal communication such as eye contact, hand gestures, and purposeful pacing.
- d. will be able to modify their oral delivery such as volume, inflection, and pause points in order to accentuate important information in their speeches.
- e. will be able to analyze and evaluate others' speeches in order to provide accurate and meaningful feedback.

The overarching student outcomes are as follows:

- a. Critical Thinking – Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.
- b. Communication – In written, oral, and/or visual communication, students will communicate in a manner appropriate to the audience and occasion.
- c. Personal Responsibility – Students will practice academic honesty and be both reliable and supportive of any team/small group projects/assignments.
- d. Social Responsibility – Students will demonstrate an understanding of societal and/or social issue and will engage with all topics in an ethical, respectful manner.

This is a college-level course and expectations are those which are generally associated with those of any higher academic courses. While the Course Instructor and Classroom Facilitators are available to provide day-to-day instruction and to assist students through their academic journeys, students, themselves, are specifically responsible for their commitment to being successful.

Students need to be familiar with the East Texas A&M University learning management system (myLeo Online), know how to use a personal computer/laptop, navigate the internet, and use basic word processing software such as Microsoft Word, Google Docs, PowerPoint, Google Slides, and Canva. This course does not provide instruction in these areas.

## **INSTRUCTIONAL METHODS**

This is an on-line course offered and credentialed by East Texas A&M University. Similarly, the Course Instructor is a credentialed Adjunct Professor with the university. The design of this course and all of the associated student deliverables and learning outcomes are consistent with university expectations and are within the Course Instructor's recognized areas of expertise.

  - Any act of academic dishonesty on a Classwork Activity will result in a score of 0 for that event. There will be no opportunity for make-up or remediation. The Course instructor MAY advocate for student removal from the course.
  - Any act of academic dishonesty on a Major Activity (Speech Outline, formal presentation) will result in a 0 for the entire semester's exam grade. There will be no opportunity for make-up or remediation. The Course instructor WILL advocate for student removal from the course.
  - Instances of academic dishonesty may also be referred to the appropriate offices on campus and may result in significant administrative penalties.

Classwork Activities:

- a. Documentation of work completed or research conducted
- b. Classroom Facilitator verification of speech rehearsal
- c. Classroom Facilitator verification of group interaction and small group planning

Narrative Performance: A story from your life (Topic will be assigned)

Informative Speech: A traditionally organized and evidenced public speech on an important topic of public significance.

Persuasive (Argumentative) Speech: A problem-solution speech that illustrates how your solution uphold two important values.

Interview/Resume: You will create a resume and use it in type of interview with your instructor.

Student (Peer) Evaluations: You will evaluate other students' speeches and your evaluations will be returned to them.

Visuals: Slide presentations constructed through PowerPoint, Google Slides or Canva that are used to support a speech.
