Course Description

This course provides additional training in statistics. It will cover important statistical concepts. It will include instruction in using and interpreting tests of statistical tests including: advanced correlational methods, simple regression, multiple regression, logistic regression, t-tests, ANOVA, MANOVA and selected nonparametric tests. The use of SPSS will be integrated into the course.

Student Learning Outcomes

Upon completion of this course, the student will be able to:

- Identify and explain introductory terminology.

- Screen and clean the data using SPSS
- Conduct correlational analyses to include simple and bivariate correlation.
- Conduct simple and multiple linear regression and logistic regression.
- Perform comparative analyses to include t-tests, ANOVA, and MANOVA.
- Conduct selected nonparametric analyses.
