Course Description

CJ 469 Victimology. This course will present a number of different definitions of Victimology to include early theorists and recent theories as to the causes of victimization. Methods of reporting crimes, both official (government) and unofficial reports will be examined including the Uniform Crime Report (UCR). The course will offer an examination of the criminal and civil process as it relates to victims. It explains the impact of crime on victims; a global perspective of victimization; and responses to victimization.

Student Learning Outcomes: Upon successful completion, the student will be able to:

- 1. Define and distinguish between key terms in criminology and victimology.
- 2. Discuss the breadth and depth of the study of victimology.
- 3. Describe the evolution of the discovery of victims.
- 4. Critically assess issues related to theory, types of victimization, and responses to crime victims.
- 5. Identify and describe characteristics of victims of different types of crime.
- 6. Discuss the various responses to victims and victim services in the United States.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

The class will use the D2L learning management system. Students in the class may be required to use or be able to perform tasks employing Microsoft Word, PowerPoint, and using presentation and graphics programs, etc.

Instructional Methods

All assignments posted into D2L (our online system) must be on time (designated due time 11:59pm) and on or before the last designated due date. There will be no exceptions, or excuses for late assignments. There will be no make-up assignments.

Methods of Evaluation

Course Requirements: 500 total possible points

3 Exams, 1 Introduction post, 1 Discussion board, 2 Social media posts, 1 Victimology Infographic

Introduction Post: 25 points

Respond to initial introduction post on D2L. Due by January 19, 2024 by11:59pm.

- 1. Name
- 2. How this course is expected to help or aid your career, separate from the entire degree.
- 3. What area/field are you interested in? (e.g. law enforcement, case management, advocacy, etc.)
- 4. Describe how you expect this degree to enhance your career.

Exams: There will be THREE (3) exams this semester. **Each exam will be worth 100 points**. Each exam will be comprised of approximately 50 (multiple choice & true-false) questions based on assigned readings, and any materials posted online. Each exam will be timed, and you will have 80 minutes to complete the exam once it is clicked open. All exams will be posted online through your regular online portal you accessed this syllabus. You will not need to go to campus to take the exam.

Makeup Exam Policy

Makeup exams will be provided for students who have a university recognized excused absence. Excused absences include (but are not limited to): illnesses with a doctor's note, serious family emergency, special curricular requirements (e.g., East Texas A&M field trips,

conferences), participation in official university activities. Final decision of excused absences is left to the discretion of the professor.

In most instances, students will be required to provide written documentation for your absence. In addition, you MUST talk with me prior to the date of the exam in order to schedule a makeup. All makeup exams MUST be scheduled within one week of the original exam.

Note: All make up exams will be essay format. If a student misses and exam, there will be a 10 point deduction per day.

Discussion Board Questions: 25 points total

Students will participate in one (1) discussion board to better facilitate their learning of the material. Each student must also respond to at least one (1) of their fellow classmate's posts on their selected topic. Discussion posts and responses MUST be grounded in the course material. The due dates are below on the course schedule. Due by February 9th at 11:59pm in D2L.

All discussion board posts <u>MUST be a minimum of 250</u> words in length per discussion question for each post to receive credit. All responses MUST be meaningful and add to the discussion. Discussion posts that do not comply with the guidelines presented here will be given no credit, no exceptions. Marginal responses will receive reduced or no credit. Responses consisting of liking and/or agreement/disagreement with little or no substance will not count towards the discussion response grade. Please ensure that your posts and responses are respectful. A rubric will be posted on D2L (online).

<u>2 Factual Social Media Posts</u>: 100 points total (2 x 50 points each = 100 points)

As part of your coursework, you will develop TWO (2) separate social media posts on any TWO separate topics related to victimology. This can include victim rates, trends, policies, laws, etc. As part of this class, you are learning how to explain victimology and criminal behavior, while at the same time, learning how to properly state your stance using factual information obtained from OFFICIAL government or law enforcement websites. This assignment is NOT opinionated. ONLY FACTUAL.

Each post is worth 50 points each. Post should include factual data, statistics, and include at least one academic or government source. For this assignment, **you DO NOT have to actually post** this on any social media platforms. This can be done as a general post, or flyer / visual post. Rubric will be posting on D2L.

Victimology Infographic: (100 points total)

For your final project in this course, you will create a one-page infographic on one topic based of Victimology we covered this semester. Imagine you are presenting this infographic and report to someone who has little to no background in criminal justice. How would you make your infographic appealing, while at the same time, presenting the factual information related to your specific topic? You may choose any topic covered in class or related to victimology. Here are just a few suggestions:

- Preventing Crime Victimization
- Restorative Justice
- Any specific non-profit that works with victims
- Policies that address victims

- Victimology rates for a specific area, for example:
 - Human Trafficking
 - Domestic Violence
 - Child abuse / neglect
 - o Gangs
- Any theory of victimology

Detailed instructions/rubric for the infographic are posted in DL2. Final infographics are **due no** later than Sunday, April 13th at 11:59 PM either by email or through DL2.

Student Responsibilities or Tips for Success in the Course

Students should plan to regularly log onto the course website. Students should be very aware of their study habit and how much time they should commit to each class, the amount of weekly study time and participation time will impact your degree of success.

In addition, here are some other points to consider:

Tips on How to be successful in this Class:

1. Students must commit serious time to reading the textbook, and other assigned readings.

2. Student should ask questions of the professor if there is any information, he/she does not understand.

- 3. Students should regularly attend class.

APA Citation Format Policy

It is very important that you learn how to cite properly. In some ways, citations are more important than the actual text of your paper/assignment. Therefore, you should take this task seriously and devote some time to understanding how to cite properly. If you take the time to understand this process up front, it will save you a significant amount of time in the long run (not to mention significant deductions in points).

In the social and behavioral sciences (including Criminal Justice), we use APA (American Psychological Association) format. As a rule of thumb, one cites whenever they are paraphrasing other people's words or when they quote other's words directly.
