COURSE DESCRIPTION

COURSE OVERVIEW AND OBJECTIVES:

This course is geared towards teaching students the fundamentals of project management based on the Project Management Body of Knowledge developed by the Project Management Institute. In particular, students will learn about scope, time, cost, quality, human resource, communication and procurement management and develop a comprehensive project plan accordingly. This approach will assist the future manager, as one of the project key stakeholders, to understand the deliverables required of project managers and their teams.

1. Students will demonstrate proficiency in spoken communications by delivering clear and well-structured business presentations.
2. Students will demonstrate proficiency in written communications by creating clear and well-structured business documents.
3. Students will identify and evaluate ethical business issues.

5. Students will be analytical problem solvers in business environments.

COURSE REQUIREMENTS

Instructional Methods

This course is taught asynchronously through recorded video lecture on the D2L system. The information and materials needed to complete the course is in this syllabus and on D2L. Weekly one hour Zoom sessions are scheduled to answer questions and cover business ethics and global business challenges.

Student Responsibilities or Tips for Success in the Course

The online class version of this course requires the student to view the recorded lectures and complete the assignments as scheduled. Project Exercises are assigned, based on the information learned from lecture and assignments detailed in D2L. Each student will be required to log in regularly into the course website to access the weekly lectures and homework assignments. Quizzes will be open-book and taken in D2L. These quizzes will be based on the lecture material. The final exam, which covers all material taught during the semester, is also open-book and taken in D2L.

PROJECT EXERCISES:

Project exercises will be done as individual homework assignments. These project exercises are in a case study form and will be used to complete project management activities on the four phases of the project. Exercises include developing a project charter, WBS, project schedule, risk assessment, communication grid, RACI chart. Additionally, there are two LinkedIn badges for PMI Kickoff that need to be posted on LinkedIn. Each student will need to create a LinkedIn account and connect with the instructor by September 1st.

QUIZZES AND FINAL EXAM:

Quizzes and the Final Exam will be administered through D2L to test understanding of project management concepts through the four phases of a project as taught from the lectures. The final exam, a comprehensive review of project management, will be given on the last week of class.

2. Assignments must be turned in on time. Assignments are due by the date and time listed (see D2L). While the syllabus designates specific dates for which work is assigned, do not wait until the “assigned” date to start working on it (or to turn it in).
3. **LATE ASSIGNMENTS WILL NOT BE ACCEPTED. IF YOU DO NOT MEET THE 11:59 PM DEADLINE (EVEN ONE OR TWO MINUTES), YOU WILL RECEIVE A 0 FOR THAT ASSIGNMENT.**
4. **There are no make-up assignments for poor performance on a previous assignment.**
5. Homework Project Exercises count 40% of your final grade.
6. Use of any Artificial Intelligence to generate reports and homework assignments **is not forbidden as long as the student states usage of the A.I. tools and provides clear instructions of the prompt as an appendix in the last portion of the assignment.**
Submitting any work without proper review will severely drop your grade. (see details in page 7 - AI Policy for this Course)

Quizzes (General Comments): Quizzes count 30% of your final grade.

Final Exam (General Comments): The Final Exam will count 20% of your final grade. The scope includes the comprehensive review of project management as in the textbook, presented in the lectures, and topics covered in the bi-weekly Zoom sessions.

Attendance: Attendance will account for 30% of the final grade, reflecting its importance in ensuring active participation and engagement. This includes one potential in-person event during the semester. If you are an out-of-state student or do not reside in the Texas DFW area, please notify me by February 1, 2025, so accommodation can be discussed. Your timely communication is essential to ensure your ability to meet the course requirements effectively. .

AI Policy for this Course

Purpose:

This policy outlines the acceptable use of Artificial Intelligence (AI) tools in this course to ensure academic integrity while allowing students to leverage AI for learning and research purposes.

Use of AI in Coursework:

Permitted Use: Students are allowed to use AI tools for research and drafting their homework assignments. This includes generating text or images as part of the research and preparation process.

Prohibited Use: AI tools are not allowed during exams. All exam responses must be the student's original work, created without AI assistance.

Required AI Disclaimer:

IF AI TOOLS ARE USED, STUDENTS MUST INCLUDE A DISCLAIMER IN THE FIRST PARAGRAPH OF THEIR ASSIGNMENT. THIS DISCLAIMER MUST CLEARLY STATE:

- The name of the AI tool(s) used (e.g., ChatGPT, DALL-E, etc.).
- The type of content generated by the AI (e.g., text, image).
- Specific prompts or questions used to generate the AI content.
- A detailed note on your review and modifications, clearly stating how you evaluated and adjusted the AI-generated output to meet the assignment requirements, including specific changes made

Example Disclaimer:

"This assignment was drafted with the assistance of ChatGPT. The AI was used to generate the initial draft of the introduction and summary based on the prompt: 'Discuss the impact of ethical AI in project management.'

Review and Modifications:

- I verified the AI's content against course materials and corrected inaccuracies related to ethical guidelines in AI.
- I expanded the discussion on stakeholder roles in ethical AI to align with lecture notes.
- I rephrased sections to improve clarity and ensure the tone matched academic standards.
- I added original examples and case studies to support the arguments provided by the AI."

Consequences for Non-Compliance:

If an assignment lacks the required disclaimer and is suspected of containing AI-generated content, the work will be scanned using AI detection tools.

IF AI-GENERATED CONTENT IS DETECTED AND NO DISCLAIMER IS PROVIDED, THE ASSIGNMENT WILL RECEIVE A GRADE OF 60.

Students who disagree with the assessment can appeal by providing proof that the AI detection tool is incorrect, and that the assignment was completed without any AI assistance.
