Course Description

Student Learning Outcomes (Should be measurable; observable; use action verbs)

1. Students will understand what trauma is and how it impacts children through reading, viewings and a potential interview. Students will deepen their understanding by comparing texts through discussion.

2. Students will describe and analyze the sociopolitical and historical factors that contribute to the higher rates of trauma within a specific local context (Texas, or chosen population).
3. Students will research how trauma has been treated in recent literature with a present the findings.
4. Students will conduct a comparative analysis of a negative behaviors from the traditional response with a trauma informed response.
5. Students will create a teacher/child care workers' guide to identifying students with trauma and how to support them in the classroom (0+)

COURSE REQUIREMENTS
