### Group Project (A Maximum of 40 Points)

- Project points are very important to your final grade! **The due date for the project is 6 PM on June 29. No late submission will be accepted!** Early submission is highly recommended.
- **If you like, you can complete the project by yourself.** If you like to form a group, make sure your group has 4 or fewer members. **Submissions from groups with more than 4 members will not be graded.**
- **Each group only needs to submit one copy of the project. Please clearly list each member's first name and last name on the first page of the submission.**
