## **Course Description**

This course covers major frameworks for analyzing and characterizing types and levels of culture that matter to organizations. Examples include type of national, regional, and organizational culture. Diversity and conflict resolution will be also covered. Students will design an effective training or learning solution by applying learned concepts and frameworks.

Discuss the impact of globalization on intercultural workplace learning practices. Compare and evaluate cultural models for describing cultural variations.

Discuss the issues encountered in intercultural workplace learning practices and ways to improve such practices.

Demonstrate an advanced understanding of the roles of international HRD professionals in addressing culturally diverse employees or trainees.

## **COURSE REQUIREMENTS**

Active participation in this web-based course is expected. It is recommended that students log in into the course module weekly to stay on track with the assigned reading materials, discussion post, assignment, and project.
