**Course Description**

*The syllabus/schedule are subject to change.*

This course addresses the (a) process of verbal, non-verbal, and paralinguistic communication skills; (b) assessment of communication competence, including social skills; and (c) research-based intervention strategies and effective practices for promoting effective communication for learners with social communication impairments, including Autism Spectrum Disorders. Language development, communication and language-based assessments, social skills training, alternative/augmentative modes of communication, assistive technology devices, and the impact of contextual factors affecting communication competence will be discussed and investigated.

**Student Learning Outcomes** At the conclusion of this course, students will be able to:

1. Students will demonstrate their knowledge of the etiologies and characteristics of receptive/expressive language, cognitive communication, social aspects of communication & communication modalities in individuals with autism spectrum disorders (ASD).
2. Students will integrate developmental theories and milestones into an assessment of individuals with social communication impairments, including ASD.
3. Students will be able to identify, explain, and compare strategies and materials used to educate individuals with social communication impairments, including ASD.
4. Students will demonstrate understanding of procedures of effective assessments, instruction, and supports that target (a) social communication, (b) functional behavior, and (c) the academic performance of individuals with social communication impairments, including ASD.

## **COURSE REQUIREMENTS**

### **Minimal Technical Skills Needed**

Enrolled students will need a working knowledge of how to access the course online, access materials and resources the instructor posts, recording/posting videos, and the use of word processing programs for submitting assignments.

### **Instructional Methods**

This course will be facilitated using D2L, the learning management system used by East Texas A&M University. The instructor has included various forms of instructional tools in the course such as lecture slides, videos, helpful websites/resources, scholarly articles, and discussion topics.

### **Student Responsibilities or Tips for Success in the Course**

Students will be responsible for completing assigned readings and activities in required timelines. To be successful in this course, students should plan sufficient time to read all assigned readings and any other activities (for example, watch videos or locate websites). All work must be completed within time limits, so time management is a priority. Students must complete all assignments before the due date. In addition, students must work diligently as

#### 1.Weekly Assignments:

For each week, you will be given assignments to read, go through videos and/or lectures, and weekly assignments that will cover all the information for that week. Please read carefully the information that follows about each type of assignment.

Typically, the weekly assignments will be open for the entire week, and generally, will close on Sunday at 11:59 pm but you are responsible to verify the closing date/time of each assignment.

a. Quiz (D2L-Activities-Quizzes). You will be allowed to take the quiz only one time unless otherwise noted. These quizzes are open book, open notes, **but do not copy and paste your answers or plagiarize. Your answers should be in your own words.** The quizzes will be timed so, even though you can have access to your book, you will

need to have a good understanding of all the material in advance of taking the quiz to complete it timely.

b. Reflective Discussion (D2L-Activities-Discussions). For each discussion, you are to contribute thoughtful reflections to a thought-provoking question based on assigned readings/lectures/ videos, etc. As these are individualized reflections, you cannot copy your opinion from the text, Google, etc. and your opinion may differ from your classmates. For all discussion forum, you will be required to respond to at least one posting of one of your classmates. In responding to another person's post, be considerate and respectful. Your peer response must be posted by the next Sunday. Provide your own opinion about the discussion prompt. Provide evidence to support your opinion. Evidence must be from readings, lecture slides, other peer-reviewed articles. Please adhere to APA citation guidelines.

2. Resource Guide Repository: Students will be required to create a cloud-based repository where specific products and resources will be stored and shared with the instructor. The purpose of this assignment is to provide the student a professional resource repository to use while practicing as a service provider for individuals with social communication impairments, including ASD.

3. Case Study will include: (a) Case information - Describe demographic and contextual information on the student (b) Literature review - Review at least 5 peer-reviewed articles to support your case study. (c) Methods: Describe your case study methods (e.g. interviews, duration/frequencies, observations-durations/frequencies, illustration of the educational and cultural milieu, etc.) (d). Findings: Illustrate key findings (e.g. academic, behavioral, and functional performance, educational trajectories, postsecondary goals, special education and related services) (e.) Reflection: Provide your suggestions that can improve the student's academic achievement and functional performance. Explain how this case study impact your professional knowledge and goals.

4. Professionalism, Participation, and Good Conduct: It is expected that all products are completed in a timely manner and free of spelling and grammatical errors. Additionally, students are expected to use professional vernacular of (dis)ability culture. Respectful and culturally responsive discourse on discussion boards and interactions with the instructor are required! Professionalism in communications with the instructor and peers WILL BE EVALUATED—this is a course in social skills and students will be expected to display them throughout the course.
