Course Purpose: Welcome to PLS 1307! This course is designed to introduce students to the principles of plant science and the role of plants in society from an agronomic viewpoint.

Topics covered

- Explain the role of plants in society
- Classify crops by their biology and use
- Recognize agronomically important plant parts and functions
- Explain processes associated with plant growth and development
- Identify important agronomic crops and weeds
- Describe agronomically important soil characteristics
- Explain crop production practices, including tillage, planting, nutrient management, and pest management
- Describe methods of crop improvement
- Analyze socially important issues in crop agriculture
- Apply course content to the production of major crops in Texas

Course Work

Homework: Will be assigned directly from the course text for chapters 2, 3, 4, 5, 7, 9, 10, 13, & 15. Homework must be submitted on D2L.

Assignments: Two assignments will be given throughout the semester. These assignments are intended to mimic what you might encounter in a job and will range in format. Guidelines will be general. In most cases you will be able to use your own creative directive to determine how you will accomplish the assignment. Assignments will be focused on developing your *career competency*.

Exams: Four (4) exams will be administered. Each exam will be worth 100 points, with the potential for up to 10 bonus points. Exams will be given via D2L. You are allowed to use your textbook, notes, or online resources. You are not permitted to communicate with your peers or other individuals about the exam. Cheating will not be tolerated.

Late work policy: All assignments (except your final exam) must be submitted on or before July 2 at 11:59 pm for grading consideration.
