### **Course Description**

This course is designed to complement Wildlife Management II. As such it provides an introduction to the many dimensions of wildlife and conservation science. Topics covered include Wildlife Management, North American Wildlife Conservation, The Wildlife Professional, Human Dimensions of Wildlife Management, Structured Decision Making, Scale in Wildlife Management, Wildlife Populations Dynamics, Diseases and Parasites, and Hunting and Trapping management, and shows students how to make themselves marketable for employers across a wide spectrum of wildlife jobs.

1. Demonstrate knowledge of the North American Model of Wildlife Conservation
2. Demonstrate knowledge of the Wildlife Professional
3. Demonstrate knowledge of the Human Dimensions of Wildlife Management
4. Demonstrate knowledge of the basics of Wildlife Management.

## **COURSE REQUIREMENTS**

### **Instructional Methods**

You will be required to read the book chapters, supplemental reading material, and instructional PowerPoint slides. Quizzes and exams will cover the material presented to you via myleoonline.tamuc.edu, and information in the text.

### **Student Responsibilities or Tips for Success in the Course**

To be successful in the course, students must complete all tests and assignments on the date they are due. Thus, you, the student, are responsible for keeping track of due dates. You will also be responsible for having access to secure and reliable internet service. The successful student will arrange to complete and submit required work well before the due date to avoid connectivity issues. Always have a “plan B.”

### **Attendance and Participation:**

Each student is expected to attend all classes and participate in all discussions. This course is designated as “Online” only, so we will not be meeting live virtually each week for lectures. Instead, there will be multiple **recorded lectures (up to 1.5 hrs each) posted online on D2L available ahead of time to view each week.** The first week of classes will also include an essential video lecture providing an overview of the syllabus, introduction to the course, and course expectations will be available on Monday, May 5, 2023. Please view the overview video first. If you have any questions about assignments and the structure of the course, I will also hold a live Zoom meeting to take any questions.

Your “attendance” grade will be based on mostly on participation. If you do not attend (participate) in class, you cannot receive credit for attendance or participation. You must participate in class discussions posted on forums on our course shell in myLeo. There will be a total of 5 forum discussions posted to which you must respond to the week’s topic or questions and responses provided by your instructor and classmates.

### **Wildlife Management Critique Papers:**

You will have 2 “Wildlife Management Critique” papers due at various intervals scheduled throughout the semester. The format of these papers will consist of 3-4 page essays, 1.5 spaced, where you will respond to the 2 following questions: 1) Conduct a library search for a scientific manuscript from a peer-reviewed journal related to one of the topics discussed within the past 4 lectures in the course. Provide a brief 2-paragraph summary on how the article agrees or disagrees with any perspectives discussed directly from those chapters in the textbook; provide at least 2 examples drawn from the textbook and the manuscript; 2) Provide a brief 2-paragraph summary on the following question: What did you like most about the article and how do you see yourself applying those methods/techniques/theories in the future. How have you already applied any of those methods/techniques theories already from any prior volunteer, internship, or work experiences? Provide references, in proper citation format, from both the textbook and the manuscript.
