Course Description

In this course, students will delve into the curriculum, pedagogy, and policies that impact English Language Learners (ELLs) across any levels of education, from kindergarten to college, within a specific educational institution (their district, region or state).

Student Learning Outcomes (Should be measurable; observable; use action verbs)

 Students will be able to accurately describe and analyze the sociopolitical and historical factors that contribute to the unique linguistic and cultural needs of at least two distinct multilingual student populations within a specific local context (and ISD).

- Students will be able to compare and contrast the experiences of ELLs or multilingual learners in the local context with those in at least one other global context, identifying both similarities and key differences.
- 3. **SLO 3:** Students will be able to articulate a clearly defined problem of practice related to equitable education for multilingual learners, by better understanding the problem, (through multiple data [interviews, institutional data, lit review]) **or** by critically analyzing and synthesizing relevant theoretical frameworks (e.g., critical pedagogy, sociocultural theory, translanguaging, trauma-informed practice) to inform to develop an equitable instructional practice (the intervention) for ELLs.

COURSE REQUIREMENTS

Instructional Methods

Doctoral students are expected to be self-motivated and regulate their learning. This course includes instructional facilitation to ensure you learn from reading (texts), researching, sharing texts, designing visual to model data, and creating a PoP with a specific lens build on theoretical frameworks.
