### **COURSE INFORMATION**

Required Materials:

Theatrical Makeup kit (cream based preferred)

Supplemental Fashion make-up (lipsticks, rouges, eye shadow, etc.) as needed

Facial Cleanser

A cleanshaven, makeup free face (yours or someone else)

Hair styling accoutrement as needed

Pastels or colored pencils

(your)Flesh-toned paper - 8.5"x11" - at least one per project (recommended)

### **Course Description**

Provides the student with an overview of the hair and makeup associated with various time periods. Familiarizes students with the terminology of hair and makeup styles. Emphasis of this course will be on looks associated with Western Fashion History eras and ideals of beauty through the ages. This class will cover various techniques and research methods for creating period makeup styles, as well as creating makeup renderings and design paperwork.

1. Learn to analyze historical images for makeup cues
2. Learn to analyze a character to determine makeup needs
3. Learn to create characters through makeup
4. Demonstrate the ability to adapt contouring techniques for different eras
5. Write critically using analytical skills about the face the makeup needs

### **Assessments**

You will be graded on not just the execution of the makeup but on the completeness of the accompanying paperwork. For every makeup execution you will also need to turn in a design, a makeup worksheet, and a character story. This means that if an evaluation is worth 50 points, 25 points is on the execution of the makeup and 25 points is in the paperwork. The paperwork required for each makeup design is as follows: Rendering
