COURSE DESCRIPTION

This is 1-credit hour course. The course will be acted as a support to understand the fundamental chemistry topics covered by the lecture class CHEM 1312. The topics include chemical reaction rates, chemical equilibrium, acid-base chemistry, solubility, thermodynamics, electrochemistry, nuclear chemistry, organic chemistry, inorganic chemistry and biochemistry.

Student Learning Outcomes

1. Use LeChatelier's Principle to predict the effects of concentration, pressure and temperature changes on equilibrium mixtures.
2. Balance oxidation-reduction reactions.

GRADING

Your course grade will be based on your ALEKS grade (100%).

The final letter grade will be based on a standard scale 90-100% A, 80-89% B, 70-79% C, 60-69% D, and below 60% F. The grades may be curved, if warranted. Incomplete grades may be given only if the student has a current average $\geq 70\%$ and is precluded from completion of the course by a documented illness or family crisis.

Only non-programmable calculators are recommended on assignments. I recommend purchase of one of the following calculators, which are available for approximately \$10.00-\$15.00: TI-30X IIS (solar) or TI-30X IIB (battery) or TI-30Xa. NO OTHER CALCULATOR TYPE IS ALLOWED. ALL calculators will be checked before graded assignments in the class.
