COURSE DESCRIPTION

This is 1-credit hour course. The course will be acted as a support to understand the fundamental chemistry topics covered by the lecture class CHEM 1312. The topics include chemical reaction rates, chemical equilibrium, acid-base chemistry, solubility, thermodynamics, electrochemistry, nuclear chemistry, organic chemistry, inorganic chemistry and biochemistry.

Student Learning Outcomes

- 1. Use LeChatelier's Principle to predict the effects of concentration, pressure and temperature changes on equilibrium mixtures.
- 2. Balance oxidation-reduction reactions.
