COURSE INFORMATION

Course Description: This course is intended to advance the knowledge and application in basic principles in adult education including identifying adult learner traits, discerning between pedagogy and principles of adult education / andragogy, and adult learner motivation

Course Objectives:

Upon completion of this course and associated activities the student should be able to:

1. Operationally define and describe the characteristics of “adult learner” and/or adult learning.
2. Discuss the differences between andragogy and adult learning.
3. Describe foundational theorist positions in adult learning.
4. Describe foundational learning theories in relation to the adult learner.
5. Describe an adult learner and their characteristics and analyze the within theoretical lenses
6. Identify typical motivations of the adult learner
7. Discern common stages of learning in adulthood

COURSE REQUIREMENTS and ASSESSMENT

Discussion Posts: To help guide you through the readings and process, there will be a series of discussion posts throughout the term. You will earn points for actively engaging the process, providing thoughtful responses, and demonstrating your developing understanding of the topics (6 x 50 = 300 Points)

Journal Article Critique: You will review and critique two journal articles, one provided by me and the other selected by you in relation to this course and its topics. (2 x 100 = 200 Points)

Adult Education Theory Matrix: Much of the content of this course is based on theories of teaching, learning, and “ways of knowing”. You will create a matrix using a tabular (excel) or linear (word) format that includes the theory, key contributor, seminal writing, summary of concepts, and comments or ideas that you have on the theory. (100 Points)

Adult Learner Biography and Analysis: You will select an adult learner to interview, write a brief biography of them and create a case study of them given the tenets of adult learning and education. (100 Points)

Course Design: The flow of this distance based course is based on the authors’ choices in organization of the content and chapters in the text. You are to assume the role of a faculty member and redesign this course based on your understanding of adult education and your preferences as a learner and an educator. (200 Points)

There will be no extra credit work available.

Late assignments will earn, at maximum, a grade of 70.

***Written Assignments**

The Research Brief, presentation, and Persuasive One-page essays should be written in a format aligned with the *American Psychological Association (APA) Manual for Publication*, 7th edition. Exemptions to APA formatting will be specified when appropriate. A tutorial on scientific writing, including the use of APA format is available from the Online Writing Lab at Purdue University (<http://owl.english.purdue.edu/>). Personal face-to-face assistance with editing and format suggestions is available from the East Texas A&M University on-campus Writing Center. APA will be used for punctuation, writing style, headings, and citations.

Course Policies and Instructor Expectations:

Students are required to meet the expectations listed below:

Professional Behavior: It is important that you maintain a professional demeanor at all times, both during live class sessions, online, and via “electronic communication.” East Texas A&M University expects this from you, as do current and future employers. This course will be a good place to practice interacting in a manner appropriate to a professional setting. Participation in class discussion and instructional activities should follow the basic principles of common courtesy and decency. Rude and disruptive behavior, as well as cheating, in any form, will not be tolerated. The use of tobacco

products in the classroom, laboratory, Zoom (or other virtual meeting platforms) meetings, and field trip sites is strictly prohibited. Use of intoxicants before class is strictly prohibited and will result in your immediate removal from class. Inappropriate conduct will not be tolerated. Class Attendance Policy: Attendance is required and roll will be taken each class meeting (for online courses this is accomplished via D2L Discussions). Missing class can affect your grade. Attendance is expected. Absences will be considered excused if the instructor is 1) notified in advance and is approved PRIOR to class, and 2) the absence is related to a severe illness, participating in a university-sanctioned event, death of an immediate family member, or other absences as approved by the instructor. Students who miss class that is unexcused will NOT be given a makeup grade.

Assignments:

- 1. Submitted assignments must be correctly formatted and free of grammatical and stylistic errors.** Students should have at least some skill with software for word processing, spreadsheets, databases, graphics, presentations, and with web browsers and search engines. Spelling and grammatical errors will detract from your grade!
- 2. Assignments must be turned in on time.** Assignments are due on the date or module listed. Start working on each assignment as soon as you possibly can and make sure that you have all the assignments submitted by the specified due dates. There will be no extra credit work available.
- 3. Assignments must be complete.** You must complete and submit all components at the specified due date and time to receive credit for the assignment. Please do not turn in work that is only "half-finished" as this will reflect a grade respective of what was submitted.
- 4. Written assignments must be submitted in a format that is compatible with Microsoft Word,** if submitting electronically.
