#### **Course Description**

ECE 358 - GLB/Language Acquisition & Development in Early Childhood Education

**Course Description** 

This course focuses on language and literacy development emphasizing the interconnected nature of listening, speaking, reading, and writing. Students will plan a language and literacy learning experience that incorporates developmentally appropriate practices.

This course explores the first and second language acquisition and development of children from birth to sixth grade. Students will examine the components of oral, written, and academic language that benefit from and promote early literacy development. Special emphasis is given to the teacher's role in supporting language development, in planning developmentally and culturally appropriate learning experiences, and in partnering with parents to foster language and early literacy development. This course will address essential topics such as phonological awareness, authentic language assessment, data-driven instruction and intervention, concepts of print, emergent writing development, and the alphabetic principle.

#### **Performance Assessment Description**

By planning an interactive read-aloud that transitions into an oral storytelling activity, students will demonstrate understanding of foundational principles, concepts, and methods in language and communication (listening and comprehension skills, speaking (conversation) skills, speech production skills, vocabulary, and sentences and structure skills) through developmentally appropriate instruction that integrates learning across the domains. Students will linguistically accommodate instruction utilizing proficiency level descriptors for listening and speaking and identify the language functions related to the topic of the lesson and vocabulary essential to a student being able to fully participate in the lesson to plan language learning strategies to aid in comprehension.
