4. Identify the major health problems and influences upon health in the nation and worldwide, as well as efforts to deal with these problems.

Assessments

Syllabus Quiz (2.5%): Important information is contained in this syllabus. You are expected to know deadlines, policies and expectations. Not reading this syllabus, D2L or your emails from instructors does not excuse you from being responsible for deadlines. **This must be completed before moving on.**

Introduction Discussion (2.5%): Students will post a self-introduction **post** to D2L. For full credit, each student will need to provide a photo of themselves reply to at least one (1) classmate's post. The photos is how I learn who each of your names and wonderful faces. Must be completed.

Quizzes (45%): There are fifteen (15) quizzes throughout the duration of the terms. Each quiz will reflect recent material discussed in the text and lecture videos. Quizzes will be online via D2L. You have 2-attempts at each quiz. Take advantage of the second attempt!

Experiential Learning Activity (12.5%): There are two opportunities to fulfill the ELA requirement. Both opportunities require several hours or your in-person attendance at an off-site location (in Commerce) on a Wednesday morning. You will sign up in Week 3 for the activity you will attend. You will also write a short reflection on your experience and how it relates to public health.

Final Exam (20%): The quizzes are preparation for the final exam. **The final exam is comprehensive, meaning it will cover all of the chapters in the text (1-16, excluding chapter 6).** The exam will be administered online via D2L and will be made up of multiple choice, true/ false, matching, multi-select, ordering and essay questions. The final exam will open on SATURDAY, December 6th @ 8:01 am and will close on MONDAY, December 8th @ 12:30 pm, **NO EXCEPTIONS**. The final will be untimed and is open- book, open-noted but NOT open Internet. The use of Ai over any kind is not permitted and will result in a zero if the use of Ai is suspected. Please note the closing date and time in your phone/calendar/sticky note on your mirror NOW and remember, 12:30 pm is during the day when the sun is out and NOT at night. Every term a student gets this mixed up and I will not reopen the exam.

Attendance and Participation (17.5%): This is an in-person course and most of the work for this class is done in the classroom in the form of small and large group discussions and individual, partner and group activities. I have set the total attendance at 175 points (35 class days x 5 points per class). There are more than 35 days of class, which means you automatically get some freebies.

Late work: Late work will **not be accepted**. Please plan accordingly. If an emergency does arise, please communicate with me as soon as possible so we can develop a plan for completion of the course. I am happy to work with you, but you need to initiate that conversation.
