Course Description

ENG 1302 – GLB/US Written Argument/Research • 3 credit hours. This course provides students with advanced training in communication skills emphasizing the writing and reading of argumentative prose and adapting writing to alternate audiences. Students will write weekly, including such texts as journals, reading response logs, summaries of argumentative texts, argumentative papers, and longer papers integrating secondary research. Activities include close reading of sample texts, both student and professional. Some sections will emphasize special topics in both reading and writing. Prerequisites: Grade of C or better in English 1301 or advanced placement or CLEP.

Core Curriculum Course Objectives

- **Critical Thinking Skills:** to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information;
- **Communication Skills:** to include effective development, interpretation and expression of ideas through written, oral and visual communication;
- **Teamwork:** to include the ability to consider different points of view and to work effectively with others to support a shared purpose or goal;
- **Personal Responsibility:** to include the ability to connect choices, actions and consequences to ethical decision-making.

English 1302 Learning Outcomes

- **Define** important terms/concepts including, but not limited to, literacy, community, research, ethics, knowledge, ethnography, and writing processes;
- **Discuss** the ways these terms expand based on cultural and communicative practices;
- **Locate** scholarly research related to key terms/concepts;
- **Examine** scholarly, personal, and/or multimodal texts that detail varying understandings and applications of key terms/concepts;
- **Develop** writing and research processes appropriate for ethically studying the literacy of a specific community;
- **Engage** in collaboration that supports individualized and communal understanding and writing development;

- **Collect** primary ethnographic data;
- **Organize** collected data in order to understand specific literacy community practices;
- **Consider** the various affordances and constraints of composing using different technologies (analog, digital, and/or multimodal), research methods, practices, styles, and/or languages;
- **Compose** texts across different genres and media of writing that further expand key terms/concepts based on primary ethnographic research and engagement with trustworthy secondary research;
- **Reflect** on your writing experiences and literacy practices;
- **Design** individualized learning goals appropriate for a first-year writing course; and
- **Assess** individualized learning goals based on labor and performance alongside feedback from peers and the instructor.

Instructional Methods

This course is a face-to-face class, meeting **Tuesdays and Thursdays, 11:00am - 12:15pm, classroom is meeting in DTH 301**. Since we have only 75 minutes for our class, it will be important for you to be on time so we can begin as quickly as possible.

Attendance is important so you will not miss any essential information. Although you may not be able to come to every scheduled class, you will be responsible for obtaining any assignments or instructions. **It is highly recommended that you develop a contact group so you can request this information from them and not the instructor.** Your chosen group will be useful to you during the semester as you all work through the semester's coursework.

COURSE REQUIREMENTS

Student Responsibilities or Tips for Success in the Course

Each student is responsible for attending class and participating in the discussions and activities. You are also responsible for completing the reading assignments prior to class so you can participate fully and make the most of the in-class discussion. Writing assignments need to be completed and submitted prior to or on the date they are due **unless arrangements have been made with me 24 hours PRIOR to the due date.** If you need extra time for an assignment, let's talk about it. I can be very flexible **IF** I know beforehand. If you wait until after the due date, there is very little I can do for you. That means you should complete all readings and bring any notes or questions about the readings. All appointments with faculty should be honored. You may reschedule any meetings before the original meeting time if you have a conflict with the scheduled meeting. If you have a conflict with any scheduled appointments, meetings with faculty should be honored.

Attendance & Participation:

- **put your phone away** – silence your phone and do not text or surf while in class; this includes using earbuds/headphones, etc. **(The main point is to eliminate as many distractions as needed.)**
- **prepare** – before coming to class complete any readings & writing assignments
- **arrive on time** – our class time is short and we need to start on time
- **participate** – by engaging in class discussions, listening attentively, taking notes, asking questions when confused, answering questions, etc.
- **stay in class until dismissed** – There is no such thing as partial attendance, you are either here for the entire class or you are absent. Please see me if you need to be absent so we can discuss any homework/assignments. (By Paige Van Speybroeck)

COURSE ASSESSMENT

As your instructor, my approach to classroom assessment is to focus on assisting you as you conduct research and draft your papers. Any suggested clarification may require revisions, and I expect you to make revisions as needed. **Revisions are due no later than two weeks following the assignment.**

Note of some of the points to consider when you receive your grade for your drafts:

1. Did you turn in your assignment by the due date?
2. Did you complete your assignment including all the requested information?
3. If you are requested to support your argument or major point with credible sources or examples, does your paper reflect that.
