**Percussion Methods I –
*Snare & Mallets***

Course Purpose

Percussion Methods I is designed to introduce music majors to the fundamental skills of snare drum and mallet percussion performance and pedagogy. Students will learn the techniques necessary to perform and teach these instruments at the beginning band level. The course will emphasize proper grip, stroke, reading, tone production, and foundational pedagogical concepts.

Requirements

- **Attendance is mandatory** due to the hands-on nature of the class. Students will lose one full letter grade for each unexcused absence beyond two. Excused absences are at the discretion of the instructor.
- Students are expected to practice outside of class regularly.
- Most equipment will be provided. Students are responsible for any loss or damage to checked-out equipment.
- The syllabus and class schedule are subject to change.

Grading (1000 points total)

- **Performance Exams (3 total)** – 100 points each (300)
 - Short etudes/pieces on snare and mallets.
 - One-on-one performance setting with the instructor.
- **Written Exams (Midterm + Final)** – 100 points each (200)
 - Cover notation, terminology, basic pedagogy, and fundamental playing concepts.
- **Video Reviews (2 total)** – 100 points each (200)
 - Students will record themselves performing an assigned excerpt/exercise.
 - Each review will include a written self-critique of performance quality and teaching considerations.
- **Class Participation** – 100 points
 - Active engagement, preparedness, and contribution to group discussions.
- **Final Notebook** – 200 points
 - Binder including class notes, warm-ups, exercises, handouts, and assigned resources.
 - Must be organized with dividers for *Snare* and *Mallets*.
 - To earn full credit, the notebook must include:
 1. Class handouts and notes (50 points)
 2. Two articles related to percussion education with written summaries (50 points)
 3. Two concert/recital/rehearsal reviews focusing on percussion (50 points each = 100)

Materials Needed

1. One pair of Innovative Percussion IP-KW or IP-LD concert snare drum sticks.
2. 1 ½” three-ring binder with dividers.

Student Learning Objectives

Upon completion of Percussion Methods I, students will be able to:

1. Demonstrate proper grip, stroke, and tone production on snare drum.
2. Perform at a beginning level on keyboard percussion instruments (2-mallet).
3. Read and interpret beginner-level snare and mallet notation.
4. Identify and correct common performance errors in young percussionists.
5. Discuss and apply pedagogical approaches for introducing snare and mallets to beginners.
6. Compile resources and exercises for teaching percussion fundamentals.

Tentative Course Schedule (subject to change)

Weeks 1–2: Introduction, grip, stroke fundamentals (snare); beginning reading.

Weeks 3–4: Basic rolls, dynamics, and rhythm reading; introduction to mallets.

Week 5: Performance Exam #1 (Snare fundamentals).

Weeks 6–7: Scales and stepwise motion on mallets; articulation.

Week 8: Midterm Written Exam.

Weeks 9–10: Intermediate reading, sticking variations, etude study.

Week 11: Performance Exam #2 (Mallet fundamentals).

Weeks 12–13: Pedagogy focus – diagnosing common beginner issues.

Week 14: Performance Exam #3 (Combined skills).

Week 15: Review and preparation for final exams; video self-review due.

Final Exam Week: Final Written Exam + Notebook Due.

Students are expected to demonstrate skills in pedagogy through their observation, analysis, discussion and feedback of the performances of other students. Students are expected to gain skills in this area by the observation of teaching techniques in their own private lessons and through the observation of teaching techniques of other students in studio class, guest artist classes on campus, and optional conference attendance or optional observations of master teachers online. Students will need to submit teaching videos and acquire a waiver from the student(s) in their videos.

Attendance Policy

Students are expected to attend all classes. It is the individual student's responsibility to notify the instructor of a legitimate absence in advance. It is also the individual student's responsibility to acquire any missed notes and assignments from other students and/or the instructor.
