#### **COURSE INFORMATION**

# **Course Materials**

This course has been designed using Open Educational Resources (OER) and/or materials that are available through the <u>Waters Library</u>. All materials are embedded within the course or are accessible via the internet or accessible through the Waters Library resource portal. After

taking the pretest, students are encouraged to bookmark, download, or save materials provided via the internet for use with assignments and projects in this class.

### Course Description

English 1301, College Reading and Writing, introduces students to writing as an extended, complex recursive process and prepares students for English 1302, which more rigorously examines the forms and structures of argument and means to approaching multiple audiences. In 1301, students will write regularly and work on essay organization and development. The course will emphasize close reading, summarizing, and analysis of expository texts, including student writing.

# **Student Learning Outcomes**

Completion of this course provides the student with the knowledge to:

- 1. Students will understand and practice academic honesty.
- 2. In written, oral, and/or visual communication, A&M-Commerce students will learn to communicate in a manner appropriate to the audience and occasion, with an evident message and organizational structure.
- 3. Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.
- 4. Students will work toward a purpose relevant to understanding various identities and a sense of ethical responsibility and reflection on our positions surrounding language, literacy, and culture.

#### **Regular and Substantive Course Interaction**

As a general guide, students enrolled in a three-semester hour course should spend one hour engaged in instructional activities and two to three hours on out-of-class work per week in a traditional semester. Students are expected to double this effort of engagement given that this course is being delivered in a seven-week term. Educational activities in this course are designed to ensure regular and substantive interaction between students and faculty to ensure that students can demonstrate competency.

To be successful in this course, all content and course modules should be read and reviewed. All assignments and quizzes (both graded and not graded) should be completed. Please contact the instructor by email for any assistance.

## **Dropping the Course Due to Failure**

Students are NOT allowed to drop a course due to failure in the course. In the event a student does not make 80% or higher on a posttest or culminating project by the third attempt, the student is not allowed to drop the course due to failure. The student is also ineligible to accelerate or re-enroll/re-take the course in the current term.

To drop a course, students must have passing grades in the course or have not attempted any assignments in the course. Please reach out to an academic advisor to drop a course.

#### **ACCELERATION IN CBE COURSES**

Students enrolled in competency-based education courses in the College of Innovation and Design are permitted to accelerate from one CBE course to another during a seven-week academic term under certain conditions. The request to accelerate from one course to another must be initiated by the student upon successful completion of currently enrolled CBE courses. Students are responsible for maintaining communication with faculty and their assigned advisor(s) throughout the acceleration process. Students who fail a course or who drop/withdraw from a CBE course are not eligible for acceleration. Student may only request permission to accelerate in one course at a time. Request to accelerate is initiated and completed by 5:00 pm CST on the fifth Friday of a seven-week academic term.

# **Acceleration Process:**

- 1. Student successfully completes all required coursework in their CBE courses(s) with a grade of "A" or "B."
- 2. Student receives emailed verification from the assigned instructor that the course has been satisfactorily completed (Grade of A or B only).
- 3. Student contacts assigned advisor to provide proof of completion and discuss eligibility for acceleration into another course.

#### **CID Policy on Academic Integrity**

- Students who commit academic dishonesty will receive a grade of 0 for the assignment in the course and be issued a Written Warning that is reported to the CID Assistant Dean's office and listed in a database.
- If the student does NOT have a previous Written Warning for academic dishonesty reported in CID courses and has additional attempts available for the assignment, the student may resubmit the assignment (this applies to CBE courses only).
- If the student has a Written Warning of academic dishonesty reported in CID courses, the student may NOT resubmit the assignment, and the instructor will follow the procedure detailed in <u>Policy 13.99.99.R0.03</u> for Undergraduate Academic Dishonesty and report the incident to the Provost Office.

#### **Submitting Past Work**

#### **COURSE ASSESSMENTS**

### **Requirement for Successfully Passing Course**

Students <u>must</u> achieve 80% or higher for **every** posttest **and** culminating project to demonstrate mastery of all competencies and pass the course.

# **Using Remaining Attempts to Improve Grade**

Students are permitted to use remaining attempts on a posttest and/or culminating project after scoring 80% or higher to attempt to make a higher score on the assignment. Students are not permitted to exceed 3 attempts for any posttest or culminating project.

- **Must** complete <u>all</u> required posttests and culminating project and receive a grade on the assignments before doing additional attempts.
- The **highest** grade achieved on the posttest or culminating project will be used for the **final grade** for the posttest and culminating project.
- Please keep in mind that submitting during the final days and hours of the term means that you may not have time to resubmit or receive feedback.
- Once you have accelerated out of the course and received a completion email, you may not return to the course to resubmit work.

#### **Pretest**

The purpose of the pretest is to provide students with a baseline understanding of your knowledge in the competency. Pretests are taken once and should be completed upon the first couple of days of a CBE academic term or entry into a course if a student is an accelerator. The pretest is required before you begin studying course materials. A passing score on the pretest does NOT provide permission to skip required assignments in the course. The grade on the pretest does **not** count in the final grade for this course.

#### **Posttest**

At the end of a module or course is a comprehensive exam that assesses student knowledge and understanding of major concepts, theories, processes, etc., in the module or the course. A score of 80% or higher is required to demonstrate mastery of the competency. If a student scores less than 80% on a posttest, the student will have an opportunity to review the material and retake the posttest two additional times. Students who fail the posttest should review feedback from the instructor before reattempting the posttest on another attempt. If the posttest score is less than 80% within three attempts, students will receive a grade of "F" in the course and will be required to retake the course in the new term. All posttests in the course have a due date: Last day of week 7, Friday by 11:59 PM CST.

#### **Culminating Project**

The final project in the course assesses your knowledge of terms and the application of concepts presented in this course. A **score of 80% or higher is required** to demonstrate mastery of each competency. If students score less than 80% on the culminating project, they will have an opportunity to review the material and resubmit the project up to two additional times. If the culminating project is less than 80% within three attempts, students will receive a grade of F in the course and will be required to retake the course in the new term. **If you want feedback for revisions, submit by the end of week 6.** Culminating projects have a due date: **Last day of week 7, Friday by 11:59 PM CST**.

#### **GRADING**

A score of 80% or higher on the Culminating Project and all Posttests is required to demonstrate mastery of the competencies and receive credit for the course. The following items will be used to calculate the final grade in the course.

Module 1	Competency 1: Academic Honesty / Reflection, teaches you to understand and practice academic honesty. Throughout this course, you will be asked to read sources and use them in your writing. Doing so requires you to quote, paraphrase, summarize, and cite the sources that you are using. Alongside citing courses correctly, however, academic honesty is also about ethics and your personal responsibility as a writer and student: making sure you don't plagiarize; using your sources responsibly, even if you don't agree with something they are writing; and being reflective about your own writing processes to show the work that you put forth is your own.	<ul> <li>Pretest</li> <li>Review Module Contents</li> <li>Posttest</li> </ul> Email your instructor when you finish your pretest so the instructor can access and grade your work.
Module 2	Competency 2: <b>Rhetorical Knowledge</b> , teaches you how to communicate in a manner appropriate to the audience and occasion, with an evident message and organizational structure. Rhetorical knowledge in this case means both understanding the audience, purpose, and context of each text, and also understanding how texts are structured to make meaning – how all the little pieces add up to the larger whole. 	of reading, you look for the rhetorical strategies of the writerthe patterns, structures, figures, & methods that a writer uses in order to make their point. This kind of reading can, in turn, help you to strategize your own approach to creating effective texts for particular audiences and purposes. Within this Competency, you will read different examples of literacy narratives as well as examples for how people (across ages, race, gender, and more) have written about and described their own literacy development. Here, you will also be asked to reflect on your own understandings of literacy, literacy development, and the ways in which literacy "sponsorship" (described by Deborah Brandt) has impacted your life.	
Module 3	Competency 3: Critical Reading, teaches you to analyze, evaluate, and solve problems when given a set of circumstances, data, texts, or art.  Specifically, this competency teaches you to think about how cultural contexts impact literacy practices. You will need to read closely, remember the text accurately, and compare the content to other texts as you develop your own understanding of literacy and literacy practices. In this Competency, you will continue to explore literacies as experienced by people in our everyday lives, as scholars, as citizens, and as community members. A key component within this module is to consider that writing doesn't just happen. Instead, by reading the texts critically, you will see how writing is shaped by our experiences, the tools we use to write, and the conditions around us, including financial, social, and sometimes even political factors. Literacy happens across borders—national borders, language borders, home/school borders, and more. 	surrounding language, literacy, and culture. In this competency, you will consider the multifaceted nature of literacy. Indeed, literacy is not one thing but rather each of us engage in multiliteracies throughout our life. Many of you probably were taught to only use Standard Academic English in school; however, there are many varieties to English (let alone languages beyond English) that we all bring to our classrooms, workspaces, communities. Some literacies become marginalized, usually because some people or institutions deem them inappropriate or unacceptable in some way. Literacy is connected to power political, social, financial, educational, cultural power and more. This competency asks us to consider how you think about literacy and why some gain dominance while others are marginalized. What factors shape which literacies we are taught, literacies we use, and literacies we preserve?	Email your instructor when you finish your pretest so the instructor can access and grade your work.

- Many of the questions on the pretests and posttests are extended short answer or essay (with minimum word count expectations). Many of the questions on the post-tests specifically reference materials in the readings, so general knowledge will not be sufficient to answer those questions; reading the material is a must.
- All assignments must be submitted by 11:59PM/CST on the Friday of Week 7 of the term.
- A score of 80% or higher on the Culminating Project and all Posttests is required to demonstrate competency and receive credit for the course.
- <u>Tip</u>: After a failed attempt at a posttest or the culminating project, review feedback provided by your instructor and/or reach out to your instructor with questions before moving to the next attempt.
