This course will consist of **extensive chalkboard and whiteboard use. Attendance will be of the utmost importance**, as well as collaboration with your peers in the event of an absence to get the note material.

Course Description

This course is an in depth look at the Anatomy (location) and Physiology (function) of animals. Specific anatomical differences will be highlighted along with physiological pathways and processes which are required for homeostasis. The semester will follow the outline of topics listed below with exams at the completion of material or at the instructors' discretion. Exams may range from multiple choice to free response or essay questions. Material that coincides with dissection lab may or may not be included. Dissection lab will include in depth dissection and interaction with available specimens to enhance conceptual and anatomical knowledge congruent with lecture material.

1. Be familiar with anatomical terminology, descriptions and locations of important anatomical landmarks in animals.
2. Understand the correlation of anatomy to physiological processes.
3. Understand and apply universal physiological mechanisms necessary for homeostasis in animals.
4. Know the function and importance of each system within the body to homeostasis in animals.
5. Be able to locate and identify anatomical landmarks in dissected specimens and describe their functions related to homeostatic principles.
